Committee reports:

Notes from the committee reports that were presented during the board meeting are below.

Archery report:

Ken Deleone presented.

The 3D Shoot went well. We had almost 200 attendees. The POS system worked well for the event. We want to give a special thanks to Riverside Archery and Sportsman's Warehouse for helping with prizes for the 3D shoot.

There was also a FITA tournament.

We discussed posting pictures and videos of our accomplished competitors. Mike Wichser mentioned Emma's father has several pictures and videos of Emma. They are already posted on the internet. Mike and Ken will find the posts and get them to Emylee to post on our Facebook page.

Ken received a lot of comments from people about finding our club on Facebook and our website.

Handgun Report:

Emylee Norgaard presented.

We have a ladies only first steps pistol class on August 21st and 22nd. So far, Ladies' Night has not been gaining much traction. Only one person has signed up so far. We will continue to try to increase interest in this event.

The July Rifle/Pistol Committee Meeting was on 7/12/2021. 11 people attended (two in person and 9 via Zoom). The last Range Special use class was on 7/24/2021. Eight people earned their special use last month.

We are also having some NRA pistol classes being done to try and catch up with the backlog due to covid.

The Bullseye Pistol is back and in full force. Steve Read is leading that event.

Rifle Report:

Martin Morehouse presented.

One of the people attending the last Basic Rifle class asked if the Civil Air Patrol would be able to use our facility to do their cadets' live shooting. We would need to supply an RSO. This would be on September 18th through 19th. Martin asked how much we would charge and if they would need special insurance. The board agreed we will provide the range use at no charge.

All the participants will need to sign the waiver form online. Larry M. asked Martin to make sure we were listed on their insurance policy. Martin said he would do that.

We would like to start up the indoor smallbore sessions again. We like to have them on the 1st and 3rd Monday of each month. These will be placed on the calendar.

Martin has a quote from Everett Steel for the steel to replace the Range 1 posts. It is \$595. Martin will schedule a work party.

Shotgun Report:

Bob Pritchard presented.

We discussed range lighting cost. John has a quote. Full lighting for Shotgun will be around \$30k. John S. called the NRA Range Services to get thoughts on the types of lighting that has been used for lighting ranges. He left a message. He has not heard back yet. If we only added lighting to Trap 0, it would be around \$10k. Joe asked John to get a quote on Trap 0 and then we can discuss if we should do it. Another option is to just put an incandescent light on Trap 0.

The first Shotgun Fundamentals class is on August 28th.

Gary Uhlig has a drone video and pictures of the range. Emylee will reach out to him to post them on Facebook.

At the last committee meeting, Bob P. asked if people wanted to say anything about Shotgun 5 Stand. One member said it was boring. Joe mentioned our 5 Stand is certified so we need to be careful with what we do. So, Bob will look into options.

Manager's Report:

Robert Haverstock presented.

We discussed the Trustees report before the manager report. So, we discussed most of details Robert had for his report in the Trustees report. Robert brought up trap prices. Clay prices have increased significantly (almost 10%). John W. recommended increasing our price to members and customers 2 cents per clay. Larry Mallory moved we increase our price to customers and members by 50 cents per game because of the increase of our costs for clays. Martin Morehouse seconded. Passed. The new renters' contact has been signed.

Treasurer's Report:

Dale Sieg presented.

We discussed what a great job Robert has been doing and his dedication to the club. We also acknowledged his significant contributions to enabling the rental of our facility which put us in such great financial shape during the pandemic. We discussed the Youth Fund. John W. needs to do more work on verifying what money we have collected that should be earmarked for the Youth Fund. We will start with \$15,000. John W. will make sure we have a good way to track it. We sold our first gift card online.

We have our draft taxes for Joe to sign. Dave Levinson brought up some thoughts John should talk to the CPA about.

We had a brief discussion about our P&L. Joe Rinaldi moved we donate \$500 to the Domestic Violence Unit of Snohomish County. John Sutton seconded. Passed.

Insurance is signed but we have not received a bill. Larry M. will reach out to the insurance agent. Our insurance agent is on vacation for 10 days. Larry will connect with him when he is back.

John W. suggested we continue to waive the initiation fee for returning members. John W. will send out an email from RockGymPro to old members in our database inviting them back and mentioning we will waive the initiation fee. The deadline for waiving the initiation fee will be January 1, 2022. The board believes this is a good idea. John Wooley moved we continue to waive the initiation fee for old members in our database until January 1, 2022. Martin Morehouse seconded. Passed.

Trustees Report:

Jeff LeMoine presented.

The water leak we had has been fixed. Our mower was also fixed. 96 cases of 12GA ammo were delivered. We will only sell shotgun ammo to people who are shooting at our club. We continue to look into whether or not we need to replace our wireless routers. Brian Walker suggested we dig trenches and lay cable, so we only need one router.

Robert spoke to some people familiar with our grounds and it may be too expensive and too much trouble to lay cable. Robert is continuing to look into what they want to do with Brian W.

One of the baffles has completely failed on Range 3. We continue to look at options. Joe would like the Trustees to come up with a date on when we will get started. Mike and his brother will come up with a price and have a proposal by our next board meeting.

Old Business:

Joe asked for an update on the marketing person. Dale said we did not get together yet. Dale will get together with Jeff G. and Martin M. before the next board meeting.

We now have an attorney on a retainer to develop 501c3 recommendations. Joe talked about some options that may come up. Dave L. suggested we not do a complete conversion from 501c4 to 501c3. Instead, we start an additional 501c3 organization. We will consider this as an option.

We discussed the club name confusion with the state. Joe asked the board to read the letter from our attorney and get back to Joe with questions and comments. Joe asked that we get back to him as soon as we can.

New Business:

Martin Morehouse moved that we allow 22LR rifles on the pistol range. We briefly discussed some requirements. First is that rifles will be used at far end of the range. Also, before we allow 22LR rifles, we will need to have a rifle rack installed at the end of the pistol range. John Sutton seconded. Passed.

For the Good of the Order:

Our Facebook page continues to get more attention. We had 177 different people visit our page in the last 28 days. We also have 17 new followers. Emylee posted pictures of deer that were seen on the property. People contacted here stating they did not realize we have wildlife on our property. Lastly, within the last 12 hours, someone gave us a 5-star review. This will help our club come up with higher priority in searches.

Joe Rinaldi moved to adjourn at 9:28 PM. Dale Sieg seconded. Motion passed.
