Committee reports:

Notes from the committee reports that were presented during the board meeting are below.

Archery report:

Mike Wichser presented.

There was a featured story on our archery Olympic hopefuls on King 5 last night, February 2nd. Mike has been providing ongoing training while maintaining government requirements including the use of proper PPE.

Still need to order and pick up the 7 targets that were already approved.

Mike Wichser mentioned the Snohomish Sports Council is trying to figure out a way for us to hold a state championship. A tournament is required for local archers to qualify for Nationals. We are looking to see if we can hold an event at our range. The event would be Fri, Sat and Sun on the last week of February. We will be following the appropriate government guidelines and requirements. Qualifiers need to shoot at least 60 arrows. 6 shooters in a line.

Handgun Report:

Martin Morehouse presented. Martin Morehouse had a meeti

Martin Morehouse had a meeting with the Range Masters about using Pistol Caliber Carbines (PCC) on Range 3 and they came up with a proposal. The proposal is to change the range to a 'pistol caliber' range. Pistol Caliber Carbines can only be fired from an off-hand position on Range 3. Range 3 will have a preference toward pistol shooters, as this is the only range for them. Carbines still have the option of using Range 1 and Range 2. Range 1 would still be the range to use for high-power pistols, those using rifle cartridges. Pistol special use will still be trained and tested with pistols on Range 3. Rifle special use training will include coverage of PCC use on Range 3. Joe Rinaldi moves to accept Martin's proposal. Larry Mallory seconded. Passed.

Rifle Report:

Martin Morehouse presented.

There is contention between the people participating in the benchrest competition. Martin asked for suggestions. We discussed briefly. Martin will go back to the team and ask them to adopt a nationally known set of rules.

Shotgun Report:

Joe Rinaldi presented.

Joe Rinaldi said we should hold off on starting members night for another month or so. The Multiplex is scheduled for this Sunday (2/7) in the morning. We have opened up the club house but no more than 12 people are allowed in at a time. Social distancing and wearing a mask are required.

Manager's Report:

Robert Haverstock presented.

Robert Haverstock is continuing to work on getting quotes for the automatic gate. He believes he will have several quotes within the next week or so.

Since we do not yet have the new gate, the lock for the entry will be re-keyed and keys will be ordered soon.

Renters are using more hours than anticipated which will continue to help our finances.

We are almost done with all the things our insurance company said we needed to do. We just have one more thing to get finished.

Treasurer's Report:

John Woolley presented. We will be updating the contract with our renters because they rented for more time that was in the original contract.

We are reconciling membership records to prepare it to get the records into our new systems. This is taking quite a bit of work.

Trustees Report:

Jeff LeMoine presented.

Michael Parent came to the Trustees meeting and provided a proposal. He would like to do gunsmithing, prototyping and suppressor development. Some board members do not see the benefit. Others thought members may see this as a benefit. We had a brief discussion on if and how this would benefit the membership. It was not clear how the operation work day to day. Joe asked to contact Michael Parent to probe him further on how he thinks this will work. Possibly have him back to a board meeting.

Construction cost of pistol building update was presented. The building itself will be \$1 million. Then, there is the range stuff on top of that. John Sutton thinks this is too expensive. So, they started thinking about what is the minimum we would do? We had a brief discussion on this topic. John Sutton will look into more options and come back with proposals.

The Trustees are suggesting we hire a full-time bookkeeper. The bookkeeper would not be allowed to sign for anything. Everyone agreed we need to do this. We will start looking.

Need to continue to include in the newsletter that the board member selection process is coming up. People should apply to be on the board if they have an interest.

Old Business:

Jackie Stone provided an update on the work she has been doing for marketing, our social media presence and out website.

The website went down this last month. This highlighted the need to change our system. An efficient website has 5 to 10 pages. Our current site is 50 pages. Jackie presented and we discussed several options. Of the options, we chose to go with a different platform that better supported our needs. We will be looking for a developer to help implement our new website infrastructure.

Jackie Stone asked if we could create signage in such a way we could take pictures of people using the range and post them without an additional signed waiver. Larry Mallory said we could not do that. If we publish pictures of people, we will need a signed waiver from them stating they are giving us their approval.

We discussed some changes that need to be made on our Facebook page. Someone also mentioned our phone number was removed from our webpage and needs to be added. Jackie Stone said she will take of that tonight.

We also discussed other topics related internet presence in preparation for the future and our website updates. Jackie Stone will be working on fixing all the issues that were brought up.

Jackie Stone said she will send out the link to our YouTube presence, Facebook and Instagram.

Memorial situation – Joe Rinaldi heard back from the Bothell PD and they are very excited about the memorial. Joe asked Jeff Gomes to close with the family so we can move forward.

We discussed the update to the pistol special use process. Dale Sieg needs to connect with Emylee Norgaard and Martin Morehouse to finalize the process and next steps.

Robert Haverstock will be making the final preparations this week for the new hours. Robert said within a couple weeks, we will have the new hours implemented.

New Business:

Joe Rinaldi has a friend with tractor for sale. He will get more details. It may be a good option to replace our tractor.

For the Good of the Order:

We had a brief talk about people attending the 2022 Shot Show.

Joe Rinaldi moved to adjourn at 9:15 PM. Dale Sieg seconded. Motion passed.

Special Use Update

As a reminder, each time you renew your membership, your special use endorsements count down to their renewal date. Special use renewals come every seven years. We are catching up with our records, so if your new badge doesn't have your special use noted on it, that just means that it is time to renew.

Renewal is simple - just attend the committee meeting that covers your special use, see the briefing to catch up on rules that may have changed in the past few years, and your badge will be updated.
