#### **Guest topics:**

Lou Scharbau asked if we could have a swap meet this summer. Lou suggested we have one specifically for reloading. Joe asked Martin to look at a date in July. Martin said we will look at the 3rd Sunday in July.

Matt Daly shared they have landed on the club rules for the benchrest matches. They will try to have it implemented by the end of the month. Jeff asked if these were equivalent to the CMP rules. Matt said no.

#### **Committee reports:**

Notes from the committee reports that were presented during the board meeting are below.

#### Archery report:

Mike Wichser presented.

We held an indoor National Championship at our club. There were 32 entries. Someone from California came up for the event. Ken Deleone said they ordered the 35 pieces for our 7 targets. The suppliers said it will take him a while to build them.

#### Handgun Report:

Emylee Norgaard presented. We are close to starting the new Pistol Special Use process.

She had some questions for the board. Can we qualify with the rest? The reason for the question is because when Dale and Emylee met to work on this, they noticed there was no option for qualifying using bench rest. The board said yes, benchrest can be one of the qualifications. Second, can we hold the class at 9am to 10am on Saturdays? The board said yes.

The first Pistol Special Use following the new process will occur on March 20th. All new members applying for special use after April 1, 2021 will follow the new process.

Joe mentioned he really wants us to start up a Ladies' Night.

George Smith asked why we score for Pistol Special Use and not Rifle Special Use? A few board members said the reason was historical in nature. The Rifle Special Use process has a demonstration of proficiency, but it is not scored. Dale and Emylee will discuss this further with Martin.

#### **Rifle Report:**

Martin Morehouse presented.

The next Rifle Special Use range session is on March 28th.

Our next NRA Basic Rifle Class is on March 27th.

Rifle matches are still on the calendar, with Rimfire Rifle on March 6th and Benchrest on March 20th, CMP Games Highpower match on March 14th.

Our next joint Pistol and Rifle committee meeting is scheduled for March 8th.

#### **Shotgun Report:**

Bob Pritchard presented.

April 5th will be the first members night. We will have them on the 1st and 3rd Monday nights of each month. The committee meetings will be on the 3rd Monday.

Bob asked for a status on trap 0. He believes there has been a proposal for this and it has been approved. Joe said they need to just get the volunteers to do the work. The plan was to do all the work with club volunteers. Bob said he would be talking with Andrew Goeff tomorrow.

Bob would like us to see lighting improvements. We told him we looked at lighting a couple years ago and it was too expensive. Jeff Lemoine said maybe we should revisit that because the costs may have come down.

Joe asked if there was a talk about any PITA events. Dave said there is an event on October 6th. Also, there is an event on the PITA calendar for May 8th and 9th. But, it is not on our calendar. Bob will look into this and get it on our calendar or cancel it on the PITA calendar.

#### Manager's Report:

Robert Haverstock presented.

The first quote for the automatic gate was \$100,000. So, we definitely need to get more quotes. We have two other companies identified to bid the automatic gate.

New keys are coming in. They will swap out the lock in the next week or so.

POS system is going well. Will be doing some training with the employees tomorrow (March 4th).

We recently had a Fire Department inspection and passed.

CPR training will be on March 18th.

Robert did receive ammo today for shotgun, rifle and pistol. Dave Levinson suggested we start limiting the number of boxes we sell to a customer. Jeff Lemoine suggested we post a sign that says customers should only what they are planning to shoot during that visit. Robert said he will post a sign.

#### **Treasurer's Report:**

John Woolley presented.

Our club is in the same financial condition this month as last month. Range fees are down. Renters are still renting.

John will work with Robert to roll out the new POS system on Sunday (3/7). John explained how the waivers will work in the new POS system.

We had a discussion about how long the waiver would last. We decided it would be 1 year. John said we also have special event forms to use for our special events.

We will have a budget for approval at the annual meeting in April. We are also planning for our taxes. We will need to do a firearm inventory. We had a discussion about moving some of our money around to other institutions.

#### **Trustees Report:**

Jeff LeMoine presented.

At the last Trustee meeting, they discussed the automatic gate. We are still pursuing it. John Sutton discussed refurbishing the pistol range. John suggested we do a little more work on what we really want to do with the range. Some of the potential options brought up were manual retractable targets, electrical retractable targets, and new booths. We also discussed possibly splitting range 3. We also discussed moving the activity to range 4 while we work on range 3. Mike Wichser said we need to make sure we do something that will make people want to come here. Jeff Lemoine suggested we set a time to talk about this. John Sutton said he will do that. Jeff Lemoine asked Mike Wichser if there was a timeframe planned for fixing the baffles in Range 1. Mike W. would like to get his brother down and have him look at it. Jeff L. asked if we could have him come out next week. Mike W. said he would contact him.

Lastly, they wanted to institutionalize that any vendor who comes on our property has us as an additional named party on their insurance policy.

#### **Old Business:**

Jackie discussed status of the website. She is meeting weekly with several members of the board to work on the website.

The new Pistol Special Use process will be starting in March. All members applying for Pistol Special Use after April 1st must follow the new process. Jeff Lemoine looked at the tractor that was discussed at the last meeting and it will not work for our needs. So, we will not be pursuing that tractor. Jeff Gomes said we are finalizing the Shoop memorial proposal. Jackie will have a final proposal soon and Jeff will take it to the family. They will have an update at the April board meeting.

#### **New Business:**

We discussed the election. This year will be contested for the President and a Trustee. The following people will be running for board positions: Joe Rinaldi (standing President) – President Brad Thomsen (contending President) - President Mike Wichser - 2nd Vice President John Woolley – Treasurer Jeff LeMoine – Trustee Elect Larry Mallory (standing Trustee) – Trustee John Sutton (standing Trustee) – Trustee Lou Scharbau (contending Trustee) – Trustee Matt Daly (contending Trustee) – Trustee Martin Morehouse – Corresponding Secretary Dale Sieg – Recording Secretary At the annual meeting, we will need to pass a budget for next year. We discussed things that need to be added to the budget.

Joe suggested we suspend annual awards except for the Gerard Loop Award. Joe Rinaldi nominated Ken Deleone and Dan Barton.

Joe mentioned when we get in phase 3, there is going to be a rush on this place. We need to start thinking about that.

Larry Mallory brought up Michael Parent being a local presence for FFL transfers and certain types of gunsmithing. Joe suggested we bring this up at the membership meeting next month.

Mike Wichser brought up there needs to be a door installed in the female's bathroom in the clubhouse. He will start working on that.

Lastly, Dale Sieg apologizes to everyone who called into the board meeting on March 3rd. Those people who were still on the call toward the end of the board meeting missed about 20 to 30 minutes of the end of the meeting.
