Guest topics:

We discussed a range violation. The violator was very apologetic and recognized he made a serious mistake. The Pistol Committee Chair (Emylee Norgaard) will follow up with the member to discuss the consequences to resolve the issue.

Committee reports:

Notes from the committee reports that were presented during the board meeting are below.

Archery report:

Ken Deleone presented.

Some targets have been setup for the 3D Shoot. The rest will be setup before the event. We have received several donations for the 3D Shoot prizes. Sportsman's Warehouse was one of the donors. A JOAD shoot will also be happening also. Emylee has been regularly posting information on the 3D Shoot on our Facebook page. Our new flat range targets are up. Several of the WCW youth archers have set some state records. They continue to do well.

Handgun Report:

Emylee Norgaard presented.

We are doing the Pistol Special use class every 4th Saturday at 9am. 12 people attended and 5 people were endorsed at the last Special Use. Next special use is on July 24th.

She is still working on planning to get Ladies Night going again.

Rifle Report:

Martin Morehouse presented.

18 members attended the last special use session in May and 15 in June. Next special use class is July 25th.

Continuing to plan on replacing the target post sockets and target system for range 1.

Shotgun Report:

Bob Pritchard presented.

The Stewart kids did great at the national tournament. Details of their accomplishments can be found in the WCW July 2021 Newsletter. We had a lighting contractor come in and we are waiting for a quote on the lighting for Trap 0. We established a trap fundamentals class. We will wait to start up the classes until we have a secure source of ammunition.

Manager's Report:

Robert Haverstock presented.

We had a water leak between buildings that we had to fix. It looks like there may still be another leak that we need to address. We are in the process of searching for the leak.

The seller we have been speaking with about 12GA ammo wanted us to purchase a container of ammo. We are not prepared to do that as this is significantly more than we wanted to purchase. Ammo is still not difficult to acquire but there are indications ammo will start becoming more available. We do not want to make the same mistake we made a long time ago when we purchased too much ammo at high prices, prices dropped and we took a loss.

The L&I meeting went well. We will make a couple subtle changes to our operating procedure. L&I is happy with how we are doing things.

We talked about some equipment repairs. Robert mentioned they are getting ready for the 3D shoot.

Job opens were posted on Facebook. Robert provided an update on replacing the wifi network - We were going to do that when we had the record hot days. So, we postponed working on that. This is something we will do soon. Jim Thompson mentioned after the 3D, he thinks the quad needs to be serviced. Robert said he would plan on that.

Treasurer's Report:

Dale Sieg presented.

Dale shared the numbers from the last quarter. We are in the positive. Again, our position was helped by the renters. Membership was up quite a bit last quarter. More so than usual even in non-Covid years. We also had several large expenses like the roof repair.

Trustees Report:

Jeff LeMoine presented.

In the last Trustees meeting, we discussed the L&I questions that were addressed. We also discussed the Shoop memorial proposal. Per the family's request, we have canceled this for now. They also discussed the lighting for Trap 0. As mentioned previously, we will be getting some quotes. We have a tentative plan for Range 3. The plan will be presented when they complete the details of the plan. Lastly, they discussed the need to do some work on the waterlines between building. They will be looking into options for the waterline repairs.

Old Business:

501c3 status - Joe had a free conversation with an attorney. She suggested we add a 501c3 to our club versus changing our status. The 501c3 would be education focused. Recreation use would be under our 501c4 status. It would cost \$2500 to have her look into it. We discussed and decided Joe should proceed.

We briefly talked about the marketing person. Martin will contact them and tell them we are still working on a plan and will get back to them. Martin, Jeff and Dale will get together to come up with a plan and then have the people who responded to come to our Website Meeting to discuss.

New Business:

We will open Trap 0 on Friday.

Joe spoke with our attorney. The Washington Secretary of State has us registered as Wildlife Committee of Washington Kenmore Gun Range. It looks like in the past, we had filed some paperwork that had us as Wildlife Committee of Washington Inc. This has created some confusion we need to have corrected. Joe is working with our attorney to correct this.

For the Good of the Order:

Emylee has contacted all the people who created pages before Emylee to consolidate our Facebook presence. She shutdown two more duplicate pages. She also started the Instagram account that is tied to our Facebook page. She shutdown the other Instagram account that was opened for WCW. Emylee shared the stats of our Facebook traffic. People who reached our posts doubled last month and people who engaged our posts increased by 6 times. We had 248 different people reached, 141 engaged in the posts and 11 new followers. She is spending 5 to 8 hours to keep the Facebook page up to date and active.

Reading of the last Board Member Meeting minutes:

Dale Sieg read the Board Member Meeting minutes from the last Board Meeting.

Ken Deleone moved to accept the minutes as read. Dan Barton seconded. Motion passed.

Reading of the last Membership Meeting minutes:

Dale Sieg read the Membership Meeting minutes from the last Membership Meeting. Ken Deleone moved to accept the minutes as read. Dan Barton seconded. Motion passed.

Committee reports:

A brief review of the Archery Committee's, Shotgun Committee's, Handgun Committee's, Rifle Committee's, and Operations Manager's reports follow. Also included below are brief notes from the Trustees' and Treasurer's monthly updates presented at the quarterly meeting.

Archery Report:

Mike Wichser and Ken Deleone presented. Mike wanted to thank the parents of the children. Without their support, the kids would not be able to do it.

There was a tournament in Alabama. Mike shared the success of the youth who went to that tournament. One of the youths made a World Record. One person made the World Team. The 3D shoot was successful. About 200 people attended. Several people mentioned the Facebook page was how they found out about the shoot. The POS system worked well during the event. There was a recent JOAD State Championships. One of the members shared the details of the success of the youth.

Handgun Report:

Dale Sieg presented.

There was nothing in addition to add outside of what was read from the last board meeting minutes.

Rifle Report:

Martin Morehouse presented. No change from what was read in the minutes except that he received quotes for steel sockets for Range 1.

After Martin shared the Rifle Report, a member brought up a concern he has. He said that he comes up from Renton and often there is a match on Range 1. Several times he has been up to the range, and he cannot use the range because there are people on the range from the match. He said they look like they are done but when he asks if they are done, they say no so he cannot use the range. Martin Morehouse said this should not happen. The range should only be occupied for the time period listed on the WCW calendar. Martin said if that happens again to contact him immediately.

Shotgun Report:

Bob Pritchard presented.

There will be a PITA shoot in October. Bob said we have not yet received a quote on the lighting. The quote will be for upgrading the existing traps 1,2 and 3 and new lighting for trap 0.

Operations Manager Report:

Robert Haverstock presented.

The rifle roof has been fixed. There are no leaks. We still have a bit of a rat problem, but it has been improved greatly. We will continue to address the issue.

Trap 0 is now open.

Jim Dinnie helped fix the water leak between buildings. While fixing the leak, we found our shutoff valves are difficult to get to. We will probably install new shutoff valves.

We had a Snohomish Fire and Safety check. The only issue they found was that the batteries were dead in a couple exit signs.

As we discussed previously, we were contacted twice by L&I on two separate occasions. Someone reported the club to L&I relative to compliance with Covid guidelines. We contacted them to find out what they needed. We had them out and they gave us some guidance. Overall, they were incredibly happy with what we are doing.

A member asked if we may shoot 22 caliber rifles in the pistol range. Joe said we will take this up at the next board meeting.

Trustees' Report:

Jeff Gomes presented.

Jeff asked if there were any questions from the members. Nobody asked any questions. Jeff talked about the Shoop memorial status. Per the family's request, they would not like to pursue this at this time. So, we will delay the memorial. A member asked if we had a design in place. Jeff said yes.

Treasurer's Report:

Dale Sieg presented.

We continue to be in the positive. Again, we have been helped by the renters. Not surprising, the range fees are up from this same time last year. Membership was up by quite a bit since last quarter too. Membership is even up more than usual, even compared to non-Covid years. We also had several large expenses last quarter like the roof repair.

Old Business:

Joe spoke about the POS system. He mentioned this system will allow us to get an automated gate. The badges will be able to open the gate and track usage of the range. This will provide us more information to make better financial decisions. A member asked if there is any vandalism. Joe said no.

New Business:

We started the meeting today with celebrating some of our youths' accomplishments. Andrew Gough shared all their winnings at the Nationals for Shotgun. Joe Rinaldi commented that what is more outstanding than how they shoot is how they handle themselves. Joe told the youth if they ever need funds to assist with their future tournaments that they should come to a board meeting and present their request. Joe mentioned there was an anonymous donation of \$10,000 for youth members.

Richard Ripley shared plans for the NRA classes. NRA has created distance learning for the dry class (40 people attended). The next part of the class must be on the range. They will be trying to get that scheduled soon. They are looking to do this two times per month. August 23rd and 24th will be a ladies only class. We may continue to do the ladies' only class once a month or once per quarter. Joe discussed the 501c3 status. The attorney he is talking to will take a look at our by-laws and make a recommendation if we should convert or add a 501c3. One of the things about the 501c3 is it needs to be focused on education. We already have a lot of focus on education.

For the Good of the Order:

Dan Barton had several things he wanted to bring up. He said we should have started our meeting at 7pm. Why did we start at 7:30pm? Dale Sieg said it was a mistake. Second, Dan Barton said we are not getting a good response to getting bikes for non-profits. He suggested we send out email notifications. We discussed briefly and said we will post the request for bicycles on our Facebook page, and we will send out emails.

Next, Dan said we need to have more motions during the board meetings, so we make sure business is getting done. He believes most all business decisions should be motioned. The board will consider his input.

Lastly, Dan asked if there is a handgun committee meeting. Martin said we hold it monthly. Joe would like to do something annually for Veteran's Day. He asked if there is anyone who knows of a good organization to work with. There were no ideas presented. Joe asked members to let him know if they think of one.

Ken Deleone moved to adjourn at 8:50 PM. Dan Barton seconded. Motion passed.
