WCW Members win Benchrest in California

Last month, several Kenmore members travelled down to Sloughhouse, CA, to the Sacramento Valley Shooting Center to participate in the week long National Bench Rest Shooting Association (NBRSA) 600/1000 Yard Nationals.

In addition to winning individual titles in multiple categories, two Kenmore members came out on top: Bruce Teel won the 600 Yard Overall Title for the 2nd consecutive year. Jeff Locke won the 1000 Yard Overall Title. Jeff also won the 600/1000 Combined Overall Title for the 4th consecutive year.

May 100 / 200 yard Rimfire Benchrest "Practice" Match

The inaugural 100 / 200 yard Rimfire Benchrest Match at the Kenmore Range was held on Saturday May 14th. Thirteen (13) Competitors were in attendance and a good time was had by all. The weather cooperated for the Match with some very light wind conditions which were conducive for shooting rimfire rifles out to 100 & 200 yards. Since this was a practice Match to work the bugs out of the Match operation, no official scores were recorded. However, the unofficial scores had Harvey Waldron and Mark Huber both shooting a 198 / 200 at 100 yards on the Cast Bullet target. This target has a 10 ring of 0.75 inch diameter, so these are sub 1 MOA targets. At 200 yards both Joe Little and Harvey Waldron reported scores of 185 /200 with the "IBS 300 yard target". This target has a 9 ring of 3 inch diameter or 1.5 MOA. This is very good shooting with a 22LR round at 200 yards. The combined unofficial high score for the "Practice" Match in May was Harvey Waldron with a combined 100 / 200 scores of 383 / 400.

The first regular 100 / 200 yard Rimfire Benchrest Match with official scoring and an optional "Buck – a – Shot" (1 shot at 200 yards) contest will be held next month on Saturday June 11th. As a reminder to all, shooting of rimfire rifles on Range 1 past 100 yards is NOT allowed unless it is a part of an approved Match or Event. Therefore, NO practicing with a rimfire rifle is allowed past 100 yards



Smallbore Smorgasbord results

The May 2022 Smallbore Smorgasbord 3 Position Match wrapped up on 5/21 with a 150% increase in attendance from the April match. 5 competitors shot the match on a sunny spring afternoon. There were 3 competitors in the open sights class and 2 in the scoped class.

We're shooting NRA A-23 targets at 50 yards. 5 shots in each bull, 2 standing, 2 sitting, and 4 prone for a total of 400 points overall. Competitors have the choice of using slings, open sights or scopes, and any 22LR rifle. This is a low key fun match with a focus on safety and building your unsupported shooting skills.

The top scores for this match were: Brian Walker, with 348 - 4X, Martin Morehouse with 343 - 5X, and Rick McGuire with 336 - 2X.

Mark your calendars for the next match on Saturday June 18th at 1 PM. Yes, it's an afternoon match – break off from your chores and take a little time to enjoy yourself. The match will be over by 3 PM, so you'll be home in time to get cleaned up for dinner! Public shooters are welcome, tell a friend. Emma Kim brings home a medal from the ISF !

Emma Kim, representing USA Archery and the Wildlife Committee of Washington, recently won bronze in the women's recurve division at the ISF Gymnasiade, held from 14 - 22 May in Normandy, France. The competition included 3500 athletes in 20 different sports from 63 countries.

She was the highest scoring American, as reported by USA Archery and The Shooting Wire. Her final match, against Ukraine's Dzvenyslava Chernyk, was broadcast live on the Olympic Channel, and gave Emma her first major international medal.

Emma says, "My goal is to make the senior national team and hopefully the Olympic team in 2024." John Kim, Emma's father says, "We would not have been able to attend this event without WCW support, we are extremely grateful for you all."

Steve Olheiser presented.

Steve is the junior shooting coach who is retiring. Mike Huck will be taking over as the new coach. Steve wanted to introduce the new coach. Josh Wilson has been the assistant coach and will continue to do so. John Woolley will be an assistant coach too. For the 4H state championship on 20th of May, Steve would like to be able to check out a club owned rifle to the competition. Steve cannot make the event, so he needs someone to take the rifles for the kids. Steve asked if Josh could check them out. Josh is not a member. The board said we could not check out rifles to non-members. However, we will gift Josh Wilson a membership for what he is doing for our club and our kids. This will enable him to check out the rifles.

Brian mentioned at the member meeting last month that he was interested in helping put on an event at the range. He is volunteering to do a 'Top Shot' type event (WCW Shooting Sports Interdisciplinary Match). Joe thought we would not be able to do it this year. However, Joe believes he should connect with Martin to discuss how Martin conducted the 'Youth Event' we had a couple years ago. Brian was thinking of a member only event. The primary reason he came is to let us know he is open to volunteering.

Committee reports:

Notes from the committee reports that were presented during the board meeting are below.

Archery report:

Ken Deleone presented.

Ken scheduled a food truck for the 3D shoot. We will try to use the same food truck for the PITA shoot. We received the order for the new targets. He is still checking on the four-wheeler, but he knows it is not ready. Not sure if it will be ready for the 3D shoot.

He spoke about some recent competitions our youth are participating in. One of our kids got a bronze medal in a recent event. Two of the youth are going to China. One youth is going to Normandy, France for a competition. Ken sent Ashley Gramer with the Easton Foundation an email sharing information about our range. Ken said he thought they may be a source of grants if we get the 501c3 approval.

Ken said we need to do some work to get the walk through in shape for the 3D shoot. They are working on that.

Handgun Report:

Martin Morehouse presented.

Our next NRA Basic Pistol classes are on May 14th and 15th.

Rifle Report:

Martin Morehouse presented.

Four people attended the NRA High Power Match that was held on May 1st.

We also hosted the Civil Air Patrol for another event. Several of the people received commendations.

14 people attended the last Special Use meeting (6 in person and 8 online).

Brian Lapinski is starting the 22LR position match. Martin talked about the 200-yard smallbore.

Martin said he has updated rifle range rules and they are posted.

Shotgun Report:

Joe Rinaldi presented.

The PITA shoot is this Saturday (5/7/2022). The event starts at 9am. We will be done about 3pm.

Joe mentioned we have had challenges with scheduling the Trap Fundamentals class. Joe would like to have the four instructors meet with the Shotgun Committee Lead to align on the process.

Manager's Report:

Robert Haverstock presented.

Maintenance is working on getting ready for the PITA shoot.

One of the soda machines is not working. Robert is looking into fixing it.

We continue to have problems with the bells on the ranges. They are not making the bells as a of quality as they used to. He is looking for a better solution. We received 308, 223 and 22LR ammunition.

Treasurer's Report:

John Woolley presented.

We continue to be profitable because of the renters. We purchased the archery targets for about \$11,000. Shotgun revenue is down significantly to the other disciplines year over year. We discussed why this may be. It is possible because of the ammo shortage. Another thought was the shotgun schedule. John W. suggested we add Friday evenings to Shotgun. We talked about doing more. Robert will look into what is feasible with the current staffing and he will connect with Larry once he has some recommendations.

Ken suggested we promote the shotgun schedule on our Facebook page.

Trustees Report:

Scott R., John S., Larry A., and Dave L. presented. John S. mentioned we are still on schedule for the work on Range 3. The footing is poured. We will start setting blocks on Monday. John S. is very happy with how the wall is going. Mike Wichser is working on cutting the boards for the baffles. Still targeting to have the range done by the end of the month. Scott R. talked about lighting in shotgun. He also talked about the work they are doing to get electrical to the front of property. This would allow power to archery.

Larry A. mentioned the drainage is not good in the archery range. They are going to have some people look at it.

Dave L. mentioned our insurance expired and we renewed it. Our earthquake insurance went up. Trustees believe we should continue with the earthquake insurance.

Marketing Report:

Dale Sieg presented.

Rock Gym Pro is providing a lot of information. For example, we have records for 5400 guests including email, 645 members, and 2100 raw member names including all family, senior, and life members. Martin thinks there is an email manager within Rock Gym Pro that we may be able to start leveraging. He will investigate this.

David Bowerman has decided to step away from the volunteer work he was doing with us for marketing. We want to thank David for his contributions and helping with our initial strategy.

The marketing team has decided to start a monthly targeted email and social media campaign. Every month the marketing committee will meet ahead of the board meeting to identify 3 or 4 targeted emails for that month. The same messages sent in email will be posted on our Facebook and Twitter accounts. We will share this with the board at the monthly board meeting. If the board has an additional targeted email/posts they would like sent out that month, they can share it with the committee at that time.

For this month the three emails and social media posts will be as follows:

1) Come back to the range email. Targeted distribution will be non-members who have not been to the range for 6 months or greater. Message is we would love to see you back.

2) Range 3 will be back open soon. Targeted distribution will be to members and non-members. Message is the range is back open and is safer and newer.

3) 3D archery event in July. Targeted distribution will be to all members and archery guests. Message is to say an event is happening in July.

Robb Stack is creating a brochure. We should use this for the 4th of July parade (for Dan).

Old Business:

Joe provided an update on the 501c3 status. We will likely be focusing on our facility being more of a training facility. We do a lot of training at WCW. Ellis is working on the charter stuff. Joe will ask Ellis to participate in our board meeting in June to provide an update. Our special use is considered education too. We teach people how to safely handle their firearms. John Sutton brought up the idea of a round up policy. That is, asking people if they would like to round up any payment to the next dollar and the change go to our youth sports. Joe believes this is a good idea and suggested we implement. Robert will implement this. Dale suggested creating a large lookup table for the employees to use to figure out the round up amount. John Woolley will help with this.

New Business:

No new business was discussed.

For the Good of the Order:

Martin mentioned 5 bicycles have been donated recently.

Joe would like to do something for veterans. He is looking for a non-profit. Dale said he would find out the name of the person of a non-profit he knows about.

Joe Rinaldi moved to adjourn at 9:25 PM. Dale Sieg seconded. Motion passed.
