Relay One Expert Division Target One: Keith Wilson placed first with a score of 246 9X. T.Q. finished second at 244 9X with a two way tie for third at 243 7X between Eric Carter and Mark Huber. Target Two: Keith Wilson and Mark Huber tied for first at 247 8X. Harvey Waldron was third at 244 6X with T.Q. placing fourth with a score of 243 6X.

Relay Two Sharpshooter Division: Target One. Randy Lewellen was first at 238 5X. Don Smith was second at 235 4X with Cecil Chrisinger in third at 231 4X. Target Two: Carson Mead was first with a score of 241 3X with Lonny Stevens in second at 235 3X with Cecil Chrisinger in third again at 233 1X.

### Kenmore Rimfire Benchrest Success at the N50 Tacoma Match

On Sunday August 14th, Kenmore Members Mark Huber, Kevin Kellogg, Harvey Waldron, and Keith Wilson participated in a National 50 (N50) Benchrest Match at the Tacoma Rifle & Revolver Club. National 50 Matches provide a unique setup where Air Rifles w/pellets and slugs can compete alongside 22LR Rimfire Rifles. The Air Rifles and 22LR Rimfires are broken into 3 Divisions: Pellet, Sportsman Slug/Rimfire, and Pro Slug/Rimfire. The Kenmore Members competed in both the Rimfire Sportsman and Pro Divisions. The primary difference between the Rimfire Divisions is that the Pro Division is for custom rifles or rifles with aftermarket barrels or tuners and the Sportsman Division is for original factory rifles.

It was a wonderful day for the Match and the Tacoma Club did an outstanding job of hosting the Match and making the Kenmore Members feel welcomed. A Match consisted of shooting three N50 targets for score. Each target has 25 bulls with a max score of 250. In the Pro Slug/Rimfire Division the Kenmore Members posted the top 3 scores.

It was an outstanding day for all four of the Kenmore Rimfire Competitors and they did an excellent job of representing the Kenmore range.

### Notes on the August Appleseed Event at WCW Shooting Sports

The Northwest Region Project Appleseed scheduled a long range Appleseed smallbore event at our range on the weekend of 20 – 21 August 2022. Their Washington state coordinator, Andy Song, arranged for backers and portable target stands from the Interlake Sporting Association range, and also coordinated for the instructors and range safety crew. Their shoot boss, in charge of the event for Project Appleseed, drove in from Parma, ID to run it. Martin Morehouse was the WCW representative and supervised their range use. This was the first ever Project Appleseed Rimfire Known Distance clinic held in the northwest.

Eighteen shooters signed up, all with previous Appleseed experience, including one who drove in from Montana for the event. The first shots were a single cold bore shot per shooter at Morgan's Shingle, a 4" by 5" target set at 125 yards. The rest of the match included shooting at 50 yards from standing, 100 yards rapid fire from sitting, 150 yards rapid fire from prone, and 200 yards slow fire from prone.

Many shooters earned their Appleseed Rifleman award during the event, and are looking forward to another event like this again.

### August 100/200 Yard Rimfire Benchrest match

The Kenmore 100/200 Yard Rimfire Benchrest Match was held on Saturday August 13th with 12 Competitors present. The weather conditions were good – not great – for shooting 22LR rimfire rifles at long distances. It was a cloudy day, with the temperatures in the low to mid 60's, with light to moderate winds at the start with some moderate gusts. However, by the time the 200 yard targets were shot the winds had increase to the 5-8 mph range, with some significant sporadic gusts.

The 100 yard top score went to Keith Wilson who shot an exceptional 199 out of 200. The target used was the Cast Buller target which has a 0.69 inch diameter 10 ring. His one missed shot, had to be plugged using a lighted magnifier to validate it did not hit the 10 ring. Harvey Waldron and TQ tied for second both shooting an outstanding 196.

The 200 yard target was shot under significantly more challenging wind conditions. Kevin Kellogg demonstrated his outstanding wind reading skills and took 1st place shooting an outstanding 185 out of 200. The target used was the I.B.S 300 yard target which has a 3.0 inch diameter 9 ring or 1.5 MOA. Mark Huber also did a good job of reading the wind and had a very strong score of 183 for 2nd place. TQ also had a strong performance and stayed close to the leaders shooting a 180 for 3rd place.

The overall winner of the August Match was Kevin Kellogg with a total combined score of 380 points. Mark Huber and TQ both tied for 2nd place with an overall combined score of 376.

The "Buck – A – Shot" winner in August was Steve Goodwin who shot a 10 at 200 yards under some very challenging wind conditions on the CBA Target which has a 0.69 inch diameter 10 ring.
