President's Message

I have just recently returned from an RV road trip through a large part of the state of Montana. It was good to get away and see and experience different things. I think every once in a while it is important to just abandon our daily routine. As I was driving I wondered what it is I would write about this month. My traveling partner is a long time life member of our range and we discussed many things about the range that long preceded my involvement. One thought kept repeating like a nagging pain in the posterior.

That subject was REPUTATION. Some of the often heard criticisms I have heard about our range are comments like "unfriendly" too "restrictive" and various other less than appealing rumors about how people are treated. Admittedly, I think some of those less than admirable platitudes were true. I and the board members who guide this club currently have made a concerted effort to change that reputation. I believe much of it stemmed from the conflict of membership vs. public use. Perhaps many members do not understand that public fees pay for the salaries of our employees. Membership fees on the other hand pay for the overall infrastructure and maintenance of the facility itself. I think if you take a good look at the overall maintenance of our club it exceeds reasonable standards. There is very little litter and while it is hard to keep up with overall lawn care and weed control it is generally above standards. I do not want to digress from the theme of reputation by getting lost in the minutia of housekeeping issues.

My opinion is that a bad institutional reputation is very difficult to overcome. Especially in this day and age of social media and instant feedback platforms that alert large sections of the public. I am pleased to relate that much of the negative feedback we have received in the past has abated. I often hear comments about how friendly, helpful and informative staff are particularly to new shooters and public users who are new visitors to our facility. We have changed some restrictive rules relative to number of rounds that can be loaded and sequence of firing. These things have helped to change our reputation. Some worried we would sacrifice safety in the process. That has proven to be an erroneous worry. I believe there is another component to this that is often overlooked. That is the interaction on the part of members to each other and the public. I think we all have a responsibility to be as collegial as we can to others that are using the range. Let me give you a perfect example. There is a fellow member named Manny Reyes that shoots at shotgun especially almost every Sunday afternoon. Many of us see him as an ambassador of good faith when it comes to helping new shooters.

When new shooters come to the range they are often a little confused about how to shoot trap and the protocol that is considered standard behavior while shooting. Enter Manny, who enjoins these folks with friendly banter and helps them feel more at ease when it comes to using the range. This type of helping person is not only a credit to our club but also makes people feel welcomed and looking forward to coming back. We have others who also contribute in this regard but I believe Manny's helping demeanor is a prime example of what constitutes an enjoyable experience for visitors.

In closing, I would be remiss if I didn't point out that our outreach to the community at large has also given us positive feedback. We have hosted two community meetings concerning the apartment complex that is scheduled to be built across the street. Many who have attended thanked us for providing the space for the meeting. If nothing else we want to position ourselves as concerned and involved in the general overall outlook of the community at large. For the longest time the range was viewed as a place where only firearms and archery enthusiasts were welcome. I feel by offering our facility for public use we increase our community acceptance.

Lastly, we are about to get very busy especially at the rifle range as we embark on hunting season. Please be patient and respectful and by all means attentive to the orders of our range masters.

Take care and practice good safety always.

Kenmore Rimfire Benchrest at the September N50 Tacoma Match

On Sunday September 18th, Kenmore Members Matt Daly, Mark Huber, Kevin Kellogg, TQ, John Seyler, Harvey Waldron, and Keith Wilson participated in a National 50 (N50) Benchrest Match at the Tacoma Rifle & Revolver Club. National 50 Matches provide a unique setup where Air Rifles w/pellets and slugs can compete alongside 22LR Rimfire Rifles. The Kenmore Members competed in both the Rimfire Sportsman and Pro Divisions. The primary difference between the Rimfire Divisions is that the Pro Division is for custom rifles or rifles with aftermarket barrels or tuners and the Sportsman Division is for original factory rifles.

It was a windy day with gusts in the 10 – 12 mph range with an average wind speed in the 4 - 6 mph range. It was a partly sunny with the temperature in the low to mid 60's. Once again, the Tacoma Club did an outstanding job of hosting the Match and making the Kenmore Members feel welcomed. The Match consisted of shooting three N50 targets for score. Each target has 25 bulls with a max score of 250. Being a windy day, no 250's were shot.

Of the thirteen (13) Competitors at the Match, seven (7) of them were from the Kenmore Range. Kenmore members posted top aggregate scores in both the Pro & Sportsman Divisions. It was a very tight Competition as the top 4 aggregate scores of the September Match were posted by Kenmore Members (Harvey Waldron, Mark Huber, TQ, & Keith Wilson) with only a 2 point of separation between the four of them. The highest overall aggregate score went to Keith Wilson who shot a 746 – 46X in the Sportsman Division.

N50 Rimfire National Win

A few of us rimfire guys from Kenmore were at a competition at the Tacoma Gun Club, and heard about a National Competition in Raton coming up. This was the 2022 N50 National Championship, held at the Whittington Center in New Mexico. The match at Tacoma was my first match outside of Kenmore.

I looked over at Harvey Waldron and said “Wanna Go?” He said “Sure, I have a plane”, lets go...

The first day at the Whittington Center was practice. The wind ranged from about 3 to 8 mph and changed directions constantly, gusts were as high as 15 mph. The wind was moving the bullets outside the 5 ring in both directions at 50 yards! This tournament is ALL about reading and adjusting for the wind.

So I sit at 4th place at the end of day 1 with a poor x count but just 1 point behind the leader. I have been playing it conservative to just stay in the game. Harvey is still trying to manage the wind and is sitting at 12th place. We could have never practiced for something like this at Kenmore. It is ALL about being in tune with your wind flags. The top competitor has 8 flags out. I recommend 4 at a minimum.

Harvey and I had some practice time on the second day, Sunday morning, so we decided to practice calling shots in the wind. We would read the flags and call the hold over and see who came closest.

When the final competition started, on the first CARD I dropped 2 points in the first 5 bulls! Well, it became “do or die”. I was perfect for the next 60 rounds and the x’s were dropping in place. I was starting to get a little comfortable but, as I was holding off near the end of my 3rd card, as I pulled the trigger, I noticed the wind change and I dropped a point...

Sunday evening was the awards ceremony. I had no idea if I held my position at 4th place or where I might end up at. When they brought the results in, I found my name at the top, and Harvey in 12th. As it turned out, the top 3 competitors were separated by only one point apiece, the x counts were the same so in case of a tie, it would have reverted to the first miss.

All in all, it was a great experience competing at a National Level, with my friend Harvey III.

Harvey has a much better understanding of the wind now. As he says, “the wind is my friend!” And of course, coming home with Hardware! We were proud to represent Kenmore Gun Club at this National Tournament.

Guest topics:

Mike Groff presented.
Mike was invited by Dale Sieg to the board meeting to share information about his non-profit, Four Season Fighters (<https://www.fourseasonfighters.org/>). They started the non-profit in 2018. They provide support for veterans, firefighters, and police officers. They build relationships with the people they help. Check out a video about what Four Season Fighters does at <https://www.fourseasonfighters.org/our-impact>. Joe suggested we provide our range for an event sometime. Joe said we will have further discussions about what we can do to help them.

Jackson Beard presented.

Jackson is the Training Director at Securite Gun Club. He has been working with Martin Morehouse on an opportunity to use our facility for one of their training classes. They are targeting October 22nd for a 4 hour course. 2 hours will be on the range course and 2 hours will be in a classroom (done in our Chalet). Something they will need board approval for is approval to do controlled two pair training. Because of the instructor to student ratio and that instructors are directing the shooting, Martin Morehouse believes this will be okay. Joe said he is okay with it. We will move forward. We discussed the typical rifle range fee is \$29 per person. We will work out a fee structure with them for the use of our range.

Michael Cox presented.

Michael is the owner of Safe Insite. He came to talk about a proposal he created for our range. He shared information about their organization. Some of the things they can provide are:

- Simplified orientation and special use training processes.
- Straightforward tracking of member progress and completion.
- Addition training courses for members.
- Ability to attract a new generation of members.
- Training proposal
- Outline development
- Demo videos and photos
- Videos edited into short segments
- Videos implemented into files

If we wanted him to proceed, he would be able to have the courses complete and started by January 1, 2023.

He would also be able to tie this training system to the in person training we require for our Special Use.

Committee reports:

Notes from the committee reports that were presented during the board meeting are below.

Archery report:

Larry Anderson presented.

The United States Archery Championship was held at WCW last August. There were 30 shooters from Washington and Oregon.

Handgun Report:

Emylee Norgaard presented.

We had 10 attendees at the August special use class. 7 people earned their special use. 3 people will be attending the committee meeting this month. 7 people are signed up for the September Special Use class. 3 people are signed up for the October Special Use class.

Here is some feedback I received during the last class.

- Happy there are more 7 yard options for CPL practice
 - The ground isn't as mucky as it used to be
- We discussed the Safe Insight training Mike Cox just presented. Emylee believes we should continue to have an in-person part of the Special Use training. The board agreed. If we pursue the Safe Insight training, it would be complimentary to our on range Special Use training.

Rifle Report:

Martin Morehouse presented.

Someone shot up the bench 15 300-yard target socket on Range 1. There are at least ten hits in the socket, so this is no accident. Robert and the rangemasters are checking the logs and video records. Members doing this are putting our club in jeopardy. If anyone knows anything about this, please contact a rangemaster or board member. One of the members has installed a weather station for people to use. You can access the weather information through the Events link under the Small-Bore section.

We had an NRA Basic Rifle class and an NRA Basic Pistol class in August and September, respectively. Since the last report, we had a Centerfire Benchrest and Smallbore Rifle Position match, Rimfire Benchrest Rifle match and NRA High-power match.

There was an Appleseed Project long range smallbore event on August 20th and 21st. Sixteen people attended, and it went well. One shooter came from Montana and the shoot boss came from Parma, ID.

Indoor Smallbore practice is on the calendar on Saturdays and Sundays from 2pm to 7pm.

Member James Wilson saw a new junior shooter and family having trouble getting her started with her first shots due to loud guns nearby on Range 2. He offered to coach them on Range 1, but our rules don't allow that. The family said they would just have to find a place to shoot out in the woods. What could we do to help new shooters like this? Offer First Steps classes? Offer a rain check? Allow special use holders to coach? So, Martin asked the question should we allow a special use member to take a public shooter onto Range 1? The board said not right now but we asked Martin to come up with a proposal.

Martin asked if he should contact Chuck Shaw about another Stop the Bleed class? Joe thought this would be a good idea.

Jay Greening worked up sample architectural drawings for Range 3. He did this at no cost. Should we continue with this to get the engineering done for our planned support trusses for target retrievers? Yes, we should. We should consider having him create something for Range 4. If he is willing to do the drawings for Range 4, we should consider compensating him.

We are always looking for an assistant rifle/pistol committee chair. If you are interested, please contact Martin Morehouse.

Shotgun Report:

Bob Pritchard presented.

5 stand league is going well. 25 to 30 people are attending per week. We are still working on finding an instructor for trap.

Bob will ask Martin Morehouse to include an item in the newsletter about needing an administrator for the youth shotgun program. We can tell them they do not need to know anything about instructing. We will ask them to contact Bob Pritchard.

The PITA shoot will be on November 20th.

Manager's Report:

Robert Haverstock presented.

Employee lead and hearing has started. We need to complete it by the end of this month.

We are working on the water pipe that goes under our entrance. Robert will call 811 to make sure we will not hit any utilities.

We are painting the gate and adding reflectors.

Brian Walker installed new routers and modems in Shotgun and the Clubhouse. Thank you, Brian! Dale will contact Brian to get further details on managing the system.

Treasurer's Report:

John Woolley presented.

Our income remains down. Our costs are also down. Employee pay is down. John answered questions from the board.

Year over year our revenue has been cut in half. This is concerning. We need to continue to be frugal with our money.

John has closed our Paypal account since we are not using it.

Trustees Report:

John Sutton presented.

We discussed the water pipe repair.

We finished initial work on Range 3. The next step is to add the air and lighting.

We also need to fix a chipped stair. We still need to complete the handrail. We got a quote for drainage in the FITA field. It is \$71,400 which includes tax. If we choose to do this, they could start on 9/19 and be done in 8 days. Cost of the materials would be about 1/2 of the cost.

Larry Anderson moved we proceed with adding the drainage to the FITA field. Dave Levinson. seconded. We had a discussion. Failed with a vote of 5 yes and 6 no.

Marketing Report:

Nothing presented.

Old Business:

We discussed the initiation fee. We decided to keep the initiation fee, but we would start offering monthly payments (includes the initiation fee plus monthly dues). So, after the first year, the monthly payment would go down to just cover the monthly dues. For monthly payments, we will add a nominal fee to cover our costs. John Woolley will look into this.

Robert suggested we shutdown shotgun to the public on Mondays. There will be no 5-stand for members on Mondays. We discussed and decided we will start this on November 6th. So, the last day for Monday public shotgun will be on Monday is October 31st.

We discussed the DBA of our club. Quite a while ago, we had discussed changing our DBA to WCW Shooting Sports as a part of removing the Inc from our name to align with our filings with the state. We changed our URL, and a lot of work was done to implement the new DBA. Recently, a proposal was made to change the DBA to Kenmore Shooting Sports. Dale brought this back up for discussion. Dale moved to change the DBA to WCW Shooting Sports as the only DBA. John Woolley seconded. Passed.

New Business:

We discussed information shared with the board regarding use of our facility for JOAD and other activities. JOAD is an important program to our club, and we want to keep it going. We need to make sure we are following our by-laws to ensure the future of this program and the club. Larry Anderson shared his insights about WCW's Ed Eliason JOAD program. The board agreed we need to have the proper contracts and agreements in place for JOAD and all other like programs.

Larry Anderson will connect with the appropriate people from the JOAD program to come up with a proposal to get us in compliance with our by-laws. We will revisit this in November since Larry cannot attend the October board meeting. At that time, Larry Anderson will provide an update. We have a Special Members meeting on September 14th. This will be to vote on the new by-laws to support our attempt to change to a 501c3 organization.

Another community meeting about the apartment complex being built across the street will be on 9/19.
