President's Message

Sometimes I have to present difficult, even distressing news. But before I do let me recap what happened to us during the pandemic. As everyone knows we closed down completely for a while as did many other businesses. We have a rather unusual situation in the fact that we have a membership arrangement as well as running a business that caters to the public. Without a doubt sometimes these competing forces come into conflict but that is a subject I will skirt in this message. Once we were able to reopen we found out that we weren't eligible for any stimulus funds. This is primarily due to the fact that we operate as a 501-C-4 entity. This is akin to knitting clubs and that type of leisure activity. I suppose when the range was founded the organizers didn't envision what it would turn into 70 something years into the future. I actually was talking to an old retired lawyer friend and explaining that we were a 501-C-4 and he was flabbergasted in that he had never heard of a 501-C-4 status before. In any event, we were saddled with a real pinch financially.

Now for a little good news. We were fortunate enough to rent the range to essential renters who were exempt from the mandates of the pandemic. We continue to maintain that relationship to this day. The down side of that was we have had to adjust our hours and leave approximately two days a week open for the renters. Without this support we would be in real financial pickle these days. The fact of the matter is the range is barely self-supporting based on just the intended activities of the shooting sports in general. This is one reason we are moving to realign our status to a 501-C-3 status. This would allow for charitable tax deductible contributions for our range. We have also redone our bylaws and articles of incorporation which if approved at the January members meeting will allow a streamlined way to conduct business. While I am at it let me point out that we had a quarterly membership meeting on October 12th. We had a grand total of three members attend. We realize it is hunting season and many of our members are out on their annual outdoor adventures. Nonetheless, we as a board value the opinions of the membership even if it is critical of some of the things the board does. I would rather be questioned than ignored.

Writing this next paragraph is not easy for me. Yes everyone, we are in a real inflationary spiral at the moment. I paid \$8.00 for a large bottle of ketchup the other day. The bottom line is that we are going to have to raise the price of membership as well as public fees. The next board meeting will be a flurry of conversation as to how much that will be. I can assure you that we will be fair and as equitable as possible in the consideration of raising fees. Some of the things that we already did to ease the

sting is the approval of anniversary dates of membership. In the past memberships were collected between December and January. Now, if a member joins the club in June let's say, that will mark their renewal date. Secondly, we are now embarking on monthly payments much like gym memberships. In this way, members won't be required to shell it out all at one time. As many of you may know we did not raise the costs to reflect CPI last year as we felt that everyone lost a significant use time at the range as the pandemic was abating. So that's it folks on this subject. I think it is important to be transparent. That includes the subjects like the one outlined above.

Before I sign off let me bring up two issues. The first, is we once again have a need for a marketing person. If we can find someone within our ranks that might be interested in taking on this challenge negotiation. we are open to Secondly, I need to make a public note of appreciation to Tim Lade. Up at shotgun there are three distinct activities. The first is straight trap and we host usually a couple of competitions each year. The second is continental which allows for two shots at the same target that go in faster and different angles. There is an annual competition amongst many clubs that happens during the winter months. Then there is five stand. This activity is what I would consider the most difficult to master and attracts a certain group of participants that are not that connected to trap shooters or continental shooters. By the way, we have some top national shooters that compete in this shooting sport. This is where Tim Lade comes in mind for recognition. Tim in addition to being a top shooter was asked by me, actually maybe a little nagged by me, to put on a five stand competition. It ran in the later part of the summer and was a rousing success. So much so that many of the participants are looking forward to the next round of competition. So, thank you Tim and everyone who assisted him in making this a great success.

Kenmore 100/200 Yard Rimfire Benchrest Match for October

The Kenmore 100/200 Yard Rimfire Benchrest Match was held on Saturday October 13th with 11 Competitors. It was a sunny day with the temperatures in the low to mid 60's. The wind was perfect for the entire match which made for excellent shooting of 22LR rimfire rifles at long distances and some record scores. From start to finish the wind flags were limp with occasional light ripples. The Range 1 weather station had the wind speed in the 0 to 2 mph range for the entire Match. This was also the last 100 / 200 Match for 2022. The next Match will be held the 2nd Saturday of April in 2023.

The top 100 yard score went to Mark Huber who shot a perfect score of 200 out of 200 for 1st place. The target used was the Cast Bullet target which has a 0.69 inch diameter 10 ring. His score also set the record for the top 100 yard score shot at the Kenmore 100 / 200 Yard Match. John Seyler and Keith Wilson both shot an outstanding 198 tying for 2nd place.

The top 200 yard score went to Keith Wilson who shot an outstanding 190 out of 200. All 20 of his shots fit within a 3 inch or 1.5 MOA circle at 200 yards. This also tied the top 200 yard score shot at the Kenmore 100 / 200 Yard Match. Mark Huber kept up his hot shooting on the day and shot an outstanding 189 just 1 point back of Keith for 2nd place. Harvey Waldron kept pace with the leaders and shot an outstanding 200 yard score of 188 for 3rd place.

The overall winner of the October Match was Mark Huber who had a stellar day shooting a total combined score of 389. Keith Wilson was only a point back with a total combined score of 388 for 2nd place. The total combined scores of both Mark and Keith are the top two all-time Total Scores shot. Harvey Waldron finished in 3rd place with a total combined score of 384.

The "Buck – A – Shot" winner in October was Kevin Kellogg.

Match 1 Expert Division: Mark Walker finished first with a score of 103 with Jeff Lewis second at 102. There was a three way tie for third between Joshua Shaw, Larry Wright, and Bryan Zolnikov. Sharpshooter Division: Parker Letson placed first with a score of 99. Francis Higgins finished second at 98 with Pat Farrell third at 97.

Match 2 Expert Division: Jeff Lewis and Bryan Zolnikov tied for first with scores of 103. There was a three way tie for third between Joshua Shaw, Mark walker, and Larry Wright. Sharpshooter Division: Parker Letson finished first with a score of 102 with Francis Higgins in second at 100. Christian Eckhoff finished third with a score of 98.

Match 3 Expert Division: Kahn Nguyen and Mark Walker tied for first at 102. Jeff Locke and Jeff Lewis tied for third at 101. Sharpshooter Division: Parker Letson finished first with a match high score of 104! Francis Higgins was second with a score of 101 and with Pat Farrel and Christian Eckhoff tied for third at 97.

Match 4 Expert Division: Joshua Shaw and Rick Beginski tied for first with scores of 103. Larry Wright finished third with a score of 102. Sharpshooter Division: Frances Higgins and Parker Letson tied for first at 102 with Pat Farrell third at 99.

Match 5 Expert Division: Bryan Zolinkov finished first with a score of 103. Larry Wright finished second with a score of 102. Jeff Locke and Mark Walker tied for third with scores of 101. Sharpshooter Division: Parker Letson finished first with a score of 101 with Francis Higgins second at 100 and Pat Farrell third with a score of 99.

The winner of the Expert Division and Frombach Trophy was Mark Walker with a total score of 509. Larry Wright and Bryan Zolnikov tied for second at 507 with Joshua Shaw in fourth at 504. Committee reports:

Notes from the committee reports that were presented during the board meeting are below.

Archery report:

Ken Deleone presented. Ken said he confirmed order for targets for the walkthrough. We will get 1500 targets for \$1300.

We discussed looking for an instructor for new archers. Dale asked if it would be a paid position. Joe said we were open to that. Dale suggested posting a job opening.

Handgun Report:

Emylee Norgaard presented. Emylee received feedback from shooters that they liked having the shorter berm at 25 yards. People are also liking the cloth pins versus the staple gun.

September special use had eight attendees, all of which have completed their special use endorsement The Special Use class requests have been increasing since reopening the range and she has sign ups all the way into December. The next Special Use class is October 22 nd.

Rifle Report:

Martin Morehouse presented. The next NRA Basic Rifle class will be October 22 nd and 23 rd . The next NRA Basic Pistol class will be on October 8 th and 9 th .

Rifle matches for the coming month are Centerfire Benchrest and a Smallbore Rifle Position Match on October 15 th, Rimfire Benchrest Rifle on November 5 th, and CMP Games high-power on November 13 th. Indoor smallbore practice is on the calendar on Saturdays and Sundays from 2 to 7 PM. Our next joint committee meetings are scheduled for November 14 th. Two people in person and eight people online attended the monthly meeting on September 12 th. Four people were in person and six online in October.

The next special use class is October 23 rd . We are scheduling a beginning carbine class in cooperation with the Securite Gun Club on 22 October.

We scheduled Chuck Shaw for further Stop the Bleed classes on November 12 th . Youth Rifle is now on the calendar for each Friday from 7 - 11 PM in the clubhouse. Safe Insight has a class on Range 3 on the first Wednesday of each month from 10 - 11AM.

Legal Heat is still running their class about once a month in the Chalet, from 10 AM to 2 PM.

Alex Roeber has scheduled a civilian TASER class on October 29 th in the Chalet. The Appleseed Project would like to schedule an Instructor Training event in the clubhouse between now and April. This will take two days and will conflict with one weekend of JOAD so Martin will be working with the teams to figure out how we can do this. The Appleseed Project would also like to schedule two rimfire long distance clinics on April 29 th and 30 th and Sept 23 rd and 24 th in 2023. There are no routine events on those weekends. Martin added a calendar notice to show our closures on Tuesday and Thursday. Pistol shooters need an evening in the clubhouse for the bullseye league. The rimfire shooters would like to start an American Rimfire Association 50 vard Benchrest Competition. They will take care of ARA sanctioning, and administration, to be one of the first ranges to offer this in the Northwest. The nearest ranges offering this now are in Redding, CA and Nampa, ID. This would start in 2023, and they would like to use the second Saturday of each month. There is a conflict with another event on alternate months, but Martin will work with the teams to resolve this.

We are still looking for information on the person who shot up the 300-yard target socket in front of bench 15 on Range 1. The trustees are working on a plan for a work party to finish wiring and vacuum lines on the pistol range. To our members, if you notice the ranges need supplies, such as target frames, targets, or maintenance work, be sure to fill out a maintenance request and turn it in to the rangemasters. Forms are in the pocket on the door of the chalet.

Shotgun Report:

Bob Pritchard presented.

Members only Mondays is starting in November. There will be no 5-stand. The members will need to run the traps. Members will also have to close up. We are looking to have another 5 stand league in November. The last one was very successful.

Bob said it would be nice to have a group contact list for each of the disciplines. Larry suggested we collect who wants to be added to different groups during orientation. Also, we could put a signup in Shotgun and we could also put a note in the newsletter. Martin will look at how much it costs to create more email groups using MailChimp.

Manager's Report:

Robert Haverstock presented. They are continuing to work on repairing the water pipe. They are ready to cut the old pipe and put in the new pipe. He is halfway done with performance reviews. Should be done next week. We have two new shotgun employees. Pistol shooters are trying to get a day on Tuesday or Thursday. Robert will work with the renters to see what we can do.

Treasurer's Report:

Dave Levinson presented.

We are continuing to lose money. The cost of doing business has gone up significantly but we have not raised our rates to match. Next month, we will discuss options to increase our revenue including increasing our fees and rates We discussed the need of hiring a marketing person. There is an archery club that would like to rent our field. This can bring in revenue for the club. We need to do more

things like this. Another idea is we can rent the range to companies for morale events.

Trustees Report:

Larry Mallory presented. Lou Scharbau is working to get the repaired pistol range completed. He will work with Robert to complete the lighting and air. Jay Greening produced drawings for Range 3. Larry is working with him to update the drawings to address some needed changes. We will pay him \$60 per hour. We discussed the archery FITA field drainage. We received 4 quotes from different companies. They were approximately \$67k, \$79k, \$122k, and \$254k. One of the lowest bids provided 3 bids, two lower than the \$67k. That group said the highest quote would be just to triage. They would not guarantee the results because they have not done a proper study. It would cost \$15,000 for the proper study. Robb suggested we raise walkways instead of putting in drainage. Based on the new information we have and after discussing further, the board decided we need to do some more thinking about how we should approach the drainage.

The Trustees will be involved in the decisions on raises and bonuses for employees.

Marketing Report:

Nothing presented.

Old Business:

Joe Rinaldi proposes we allow Safe Insight to utilize our website to advertise his training programs. Larry seconded. Passed. The county said we cannot do the digital reader board out front of our gate.

New Business:

Joe Rinaldi proposed we donate \$1500 to Four Season Fighters. This is the non-profit that came to our board meeting last month. Dale Sieg will also contact Four Season Fighters and tell them they can use the facility.

We talked about an archery group who is interested in renting our range. We will consider this.

For the Good of the Order:

Dave Levinson said we need to have a services contract with all people using our facilities. Joe will contact our attorney to have the contracts created.

Joe Rinaldi moved to adjourn at 9:18 PM. Robb Stack seconded. Motion passed.

Rifle Report:

Martin Morehouse presented. No change from the last board meeting. Some of the highlights from the meeting was there have been some additional events scheduled. Rimfire shooters are scheduling a new match. The Appleseed program will be conducting another event.

Shotgun Report:

Joe Rinaldi presented. We are not getting a lot of trap shooters. The thought is this may be due to the cost of ammunition. 5 stand is fairly active. There is a PITA shoot coming up on November 20 th . Mondays will be members only after 10/31. We are having trouble finding someone to administer the youth training. However, we can find trainers. If anyone is interested in balaing administer the youth program

Operations Manager Report:

We are getting ready for the winter. Our fire extinguisher service came in today. A member asked how much we pay for the service? Robert did not have that information with him. The idea of replacing the fire extinguishers from Costco every year. Dave L. said the law requires we have a service certify our fire extinguishers and purchasing every year would not be cost effective.

Ken Deleone got back to Robert Haverstock with the name of the person who had some ideas about automating our current gate. Robert has not yet contacted the person to discuss.

Trustees' Report:

John Sutton presented.

As mentioned, Range 3 is almost complete with this phase of the project. We are reviewing plans for the next phase of Range 3 and will start working on plans for Range 4.

We have been discussing options for Archery FITA field drainage.

Treasurer's Report:

John Woolley presented.

Gross profit is down 12% year over year. Operating income is down 21%. Without the renters, we would be in the red \$83,000 year to date.

We need to think about what we do with dues and fees. A member said he hoped we will not raise dues significantly. He suggested we stair step it. One member suggested we tie to CPI. John Wooley asked if 10% is too much. A couple members said no. A member suggested we warn the members it is coming. We need to let people know ahead of time. A member suggested we approach Northshore School district to see if we develop a school district biathlon team. The board said if a member is willing to pursue that, we would be happy to discuss. A member said we need to increase our revenue. We agreed. A member brought up the idea of charging more for families who have children under 18 and over 18. The board will consider this.

Old Business:

None.

New Business:

Dave Levinson moved to amend the bylaws as they are published on our website as 'Amended Bylaws as proposed'. Scott Ray seconded. We opened the floor for a discussion. We discussed the changes and why we were making them. The primary reason for the changes is to enable us to apply as a 501c3 nonprofit. Passed. During the discussion, the following motions were made.

1) Dale Sieg moved to change Article III Section 4 in the 'Amended Bylaws as proposed' by deleting the second sentence. Larry Anderson seconded. Passed.

The section will now say, "The fiscal year of WCW shall begin on April 1 st and end on March 31 st ." 2) Larry Anderson moved to remove sentence and change last sentence of Article III Section 2 to say the individual membership. Scott R. seconded. Passed.

The last sentence will now say, "The dues and fees for a Junior Membership will be one-half of the above dues and fees an individual membership."

3) Dave Levinson moved to make changes to Article V Section 5. Remove the word Zoom and add a statement about allowing motions and voting. Scott Ray seconded. Passed.

The section will now say, "Meetings may be conducted inperson, or by electronic means such as video conferencing, with some or all attendees attending the meeting remotely. This includes the making of motions and voting of a quorum as defined in Article VII. " 4) Larry Anderson moved to make changes to Article V Section 6 to allow members at board meeting similar to committee chairpersons and allowing for additional board meetings. Dave Levinson seconded. Passed. The section will now say, "The Board of Directors shall meet regularly on the first Wednesday of each month. Changes to the regularly scheduled meeting will be communicated at least 30 days in advance of the meeting date. Any Member of WCW may appear and present to the Board of Directors any matter the Member deems to be a benefit to WCW. The business portion of the meeting of the Board of Directors shall be held in closed session, except that committee chairperson and members may be invited to attend from time to time at the discretion of the Board of Directors. The quorum requirement shall be as set forth in Article VII, Section 3. Additional Board of Directors' meetings may be called by the president to handle urgent or exigent issues.:

Dave Levinson moved to table vote on the amended bylaws and changes to the amended bylaws until the next membership meeting. Joe Rinaldi seconded. Passed.

For the Good of the Order:

A member shared an experience with bringing a friend to WCW. Nobody could help his friend site in his AR-10. This disappointed the member, so his friend did not become a member. He also said the condition of Range 1 was not in good shape. The Range 1 spotting scopes are not in good condition too. Robert said he would pay closer attention to Range 1 cleanliness. We will consider updating the scopes on Range 1.
