That and the fact that we are really not associated with the city of Kenmore either by proximity or otherwise seems to make sense in the name change. Ken is being replaced with a fellow archer by the name of Gabe Shank. Gabe is already very busy working out details for future archery activities.

There were 16 contestants in this month's benchrest match.

The Wally Seibert Trophy match is a 50 shot for record competition contested at 100 and 200 yards with one shot for record at each of the five record bulls on each of five target sheets at both of the distances with unlimited sighters allowed.

Winds were in the two mile an hour range with temperatures in the low 60's.

100 yard targets:

Match 1: Eleven competitors shot a score of 50 with Rick Beginski first at 50 5x followed by Ernie Snyder and Bill Rice tied for second with scores of 50 4X.

Match 2: Fourteen competitors shot a score of 50 with Tom Horn and Rick Beginski tied for first by posting 5X's.

Match 3: Thirteen competitors shot a score of 50 with Jeff Lewis and Ernie Snyder posting 5X's.

Match 4: Twelve competitors shot a score of 50 with Bryan Zolinikov and Richard Nicol posting 5X's.

Match 5: Thirteen competitors shot a score of 50 with Jeff Lewis posting a 4X count.

At the end of the 100 yard target series Rick Beginski was in first place with a score of 250 20x finishing in second was Ernie Snyder at 250 19x and Jeff Lewis third at 250 18x.

Ten competitors finished with scores of 250 and two with 249.

200 yard targets:

Guest topics:

Jay Greening presented. Jay came to the board meeting to share his initial drawings for the Range 4 updates.

Steve Read presented.

Steve came to the board meeting to ask for the bullseye events to be added to the calendar. Joe said he needs to work with Martin to get them on the calendar and will have to be balanced with all the other events. Kevin Kirkpatrick presented.

Kevin came to the board meeting to answer any questions we may have with his quote to update all cameras on our facility. He recently installed some new cameras to replace failing cameras and was asked to provide a quote to update the rest of the cameras. Dave Levinson has the quote. It is about \$20,000. The quote includes 50 cameras and 8 terabytes of backup. Joe asked how he would do it. He would do it in blocks and there would be no down time. Total time for installing the cameras is 67 to 68 hours.

Darren Barry presented.

Darren is with Next Steps Archery. He wanted to rent our range this summer for some events. They want to do host some summer programs (mini camps) and have practice time on Mondays and Thursdays. He shared some details of the costs and what they want to do. Mini camps are usually Monday through Thursday. They do them in the morning. They usually have 7 kids per camp. They will start with one camp and see how it goes. They would want to rent all three fields. Larry Anderson asked Darren to get together to go through some of the details. He left a written proposal with the board.

Committee reports:

Notes from the committee reports that were presented during the board meeting are below.

Archery report:

Ken Deleone presented. Several people went to Salt Lake City for a tournament. 13 to 14 members attended. 3 people placed. There were 4 youths in their first tournament.

Handgun Report:

Dave Rusko presented. For last January and February, we streamlined the new people orientation and special use. We will have the sessions frequently until the attendee count decreases. Martin trained Dave on the rifle special use so Dave can start helping with those.

Dave said the committee has produced 15 ideas of activities they want to the board. He had a question for the board. He wants to know if it is okay for someone to shoot someone else's gun 3 questions from committee - Can we let someone else shoot our guns when we are at the range? Joe said yes.

Rifle Report:

Martin Morehouse presented. Martin said there was an inquiry about a disabled veterans group wanting to rent our clubhouse to during the days. Martin will work with them and pursue this.

Shotgun Report:

Bob Pritchard presented. The 5 stand league will be in April. The Continental shoot was excellent. There were no complaints.

The Trap Fundamentals class was full. We are bringing on a new instructor. John Wooley said the instructor must be paid. We will make sure we do that. Bob said he would love to find out from the people who took the class if they are still shooting. Joe said we could send out a survey.

Manager's Report:

Robert Haverstock presented. We received bids for replacing the cameras and water pipes. We found out our water pressure reducer was at 150 psi instead of the normal 60 psi. All the water pipes are not fixed. They are just patched so they are currently not leaking. We need to fix them. He is working on getting more range masters. Sports Services is having their show next week. Robert will stop by to see if they have good deals on ammunition. Joe asked how difficult it is to find people to work. Robert said it is hard. He said he has 2 perspective retired people. Our biggest need is range masters at rifle and pistol.

Treasurer's Report:

John Woolley presented.

This last month's report looked reasonably good. Pistol is still the highlight considering how long it was closed.

Trustees Report:

Larry Mallory presented.

At the last trustees meeting, they discussed the camera upgrade, two ways to proceed with the water system, shotgun pricing and hours, the marketing agreement, discussed the election, the annual budget and a proposal was presented to fix the drainage on the flat archery field.

We discussed the marketing position proposal presented by Peter Goodwin. The trustees are in favor of the proposed marketing plan. If we move forward, they believe we need to review the progress in 6 months to determine if we continue the agreement. There is a concern that there would be additional costs associated with what Peter wants to do. John W. suggested we hire someone to do training instead of spending the money on the marketing proposal. We discussed this further.

We discussed adding the cost of the water pipe repairs to the budget. But, we will try to do as much as we can ourselves. Joe said Jim Dinnie thought we could have our employees do the repairs. John Sutton said our employees could do some but not all. Most of the bids were around \$50,000.

Old Business:

Martin Morehouse moved we accept the marketing plan and schedule that Peter Goodwin submitted. Scott Ray seconded. Passed. Larry Mallory suggested Scott Ray work directly with Peter Goodwin to closely monitor the progress. Scott will do that. Martin Morehouse reported that we have changed the members sign-in to request the member's initials, instead of their name, in addition their badge number.

New Business:

The board position elections will be next month. The following are the people who submitted forms to run for positions: Scott Ray was elected last year as the 2-year Trustee. So, he will automatically be a 1-year Trustee this year. This will not be an elected position.

John Sutton was elected as Trustee Elect last year. So, he will be Head of Trustees this year. This will not be an elected position. Jeff Gomes was elected as the 2nd Vice President last year. So, he will become Vice President this year. This is not an elected position.

Joe Rinaldi is running for president. Erin Mickleberry is running for 2nd Vice President.
