The Volunteer Group has provided safety training using materials and training aids furnished by the County. The training took place before participation in program activities.

Participants have been advised that they are required to wear the hard hat and safety vest furnished by the County. In addition, participants are required to wear the appropriate protective clothing during program activities.
