implications of how these new laws are and how they affect us I have an additional hope. That we may garner out of hearing what he has to say how and what we can do to push back as law abiding gun owners to protect our second amendment rights. It is my personal opinion that many people just accept these laws without questioning how they may challenge the propriety of their existence.

So that's it for this month. I will get back to the wrangling of the various things that are going on here at WCW next month.

Please plan to attend: The Washington Gun Law presentation by William Kirk on Wednesday March 20, 2024 in the clubhouse at 7:00pm. We anticipate and hope that this will be an event that is highly attended. Please make sure you wear your membership badges if you plan to attend.

Running for club president:

Personal biography of Joseph C. Rinaldi WCW member number 4314. Education: BA University of Washington 1970. MA Pacific Lutheran University 1975. Worked for the Department of Corrections for thirty years. Twenty-two years spent as a supervisor of various community corrections, probation and parole surveillance units. The position was akin to a Sergeant Major in the army. During that period of time, I lead the movement to get the division of community corrections permission to be armed while on the job. Testified in the state house at some personal expense arguing the increasing inherent danger to officers. The State Senate subsequently voted to approve arming the division in a vote of 55-12. Prior to that I became a certified firearms instructor and worked in that capacity from 1990 until retirement in 2001. I am a life member in WSLEFFIA which stands for Washington State law enforcement firearms instructors association. In 1995 won the state mayoral award for innovative community policing policy still in use today. After retirement I spent nine years working as a youth minister primarily taking kids on mission trips to do habitat work. Developed one such place in the upper delta of the State of Mississippi. I believe this contrast in activities has given me some intrinsic insights into management that are invaluable to me personally. Moreover, I believe it provides some ability to guide in management of club activities. I have been a lifelong hunter and fisherman and have a deep abiding respect for wildlife conservation.

STEEL TARGETS

We recently started using a few steel targets on Range 1, for members with rifle special use.

We will be adjusting how they are used as we get experience with them on our range. Our current use rules are:

- Use only at 100, 200, or 300 yards
- Bullets under 2850 FPS at the target
- Use only club targets
- Use 2x4 crossbars for support
- Use the target posts with the 2x4 brackets
- Or, use the single A-frame supports
- Hang the targets with the supports behind the steel, targets angled down
- Use the small target sets, carry them out and use them, then bring them back when you are done
- If you aren't hitting the steel, go back to paper
- You can use paint or stick-on targets for aiming
- Return the targets when done shooting. They hang on the back of the firing line wall.

Steve asked if Bullseye pistol can run from 9am to noon on Saturdays on Range 3.
Pistol does not open until 12 noon so this would not impact our normal hours. The board is okay with this.

Committee reports:

Notes from the committee reports that were presented during the board meeting are below.

Archery report:

Gabe Shank presented.

WCW is holding the WSAA BlueFace State Championship February 23th through February 25th. Archery would like to thank all those groups who sacrificed their time in the clubhouse to allow for this tournament.

Sixteen or seventeen WCW club members attended the 2024 Vegas Shoot. There were 4591 participants from around world. WA state had several top scores during the tournament.

The WCW Assistant Archery Chair spoke with several local clubs who are excited to attend the WCW archery tournaments this year. They have volunteered to assist our club in running these tournaments if needed. The Rinehart 3D targets arrived in mid-January. They have been inventoried and are ready to be used in a 3D shoot. We will be looking to put on our first 3D Shoot of the year on April 13-14. This would be a 30 Target fun shoot. No other range or building would be affected other than the Archery Walk Through Course.

Handgun Report:

Dave Rusko presented.

Steel targets will be made available this week on Range 3. Targets will be in zone 7 (lanes 25 through 28). Steel rules have been posted at Zone 7 and in Rangemaster office on Range 3. Steel targets will be stored outside alongside the east range wall to protect from the environment. Fragment panels have been added to all steel frames to trap tiny fragments.

Pistol Special Use members are forming a group to participate in the NRA MQP program. Members will meet monthly or bimonthly to shoot, score, and submit.

The Pistol Committee is designing a training course for new Pistol shooters. This will be similar to the rifle course Martin Morehouse presented earlier. Classes will be members only to start and will be small, personalized instruction for the members firearm.

The February and March NRA Metallic cartridge reloading classes are sold out.

April class has space available. We have not advertised these classes to the membership yet.

NRA classes are actively being promoted at new member orientation and special use meetings.

New Hunter Education event direction signs with moveable direction arrows were provided to the hunter education instructors. 46 members obtained their special use last month. 27 members have signed up for the February special use class.

142 new members in January attended the new employee orientation. We want to thank Sebastian Tomaszewski, Travis Barth, Kevin Ekström, April Bobin and Jack Bobin for assisting with traffic control, parking, and set-up.

New classroom tables and chairs have been ordered and cost \$2,806.76. This was under budget by \$2022.22. We expect to have them received before the end of February. We replaced several overhead lights on Range 3. We will continue replacing lighting fixtures with LED figures as time permits.

Cross boards have been replaced at 50 and 100 yards. Target frame uprights have been reinforced where needed. Target frame uprights need to be replaced. Martin Morehouse and Dave Rusko have made plans to perform the upgrade after the weather improves. Steel piping will be cemented into the ground to replace the cemented wood posts making the uprights quickly exchangeable. The design will be like Range 1 target frames. Previous experience suggests that this will only close Range 2 for 1 day.

Shooting bench at lane 16 has been removed and is being used to test new resurfacing methods. ETA to completion is the end of February.

There are some Clubhouse updates. The warranty replacement of the failed display panel is completed. The overhead Space-Ray Infrared heaters are weeping water during use. We contacted the manufacturer and was advised to install a drip tray to prevent drips on members below. We have observed intermittent rattling of the Space-Ray heaters during use. Safety struts are interfering. We are re-adjusting struts and adding damping material.

Lastly, the New Holland T1510 Tractor battery and battery cables were replaced. The driveline broke 2 days later. This is being repaired. The forklift broke down and needs to be replaced.

Rifle Report:

Martin Morehouse presented.

Rifle matches for the coming month are Rimfire Benchrest on February 3 rd , ARA Rimfire on February 10 th , Centerfire Benchrest match on February 17 th . We also have a CMP Games High Power match on February 11 th . The twice-yearly NRA Instructor Training for rifle, and pistol will be on February 2 nd through February 4 th . Due to instructor illness, we rescheduled the NRA Pistol Instructor course from February 3 rd through February 4 th to February 24 th through February 25 th .

Our next NRA Basic Rifle Class is on February 17 th and 18 th .

Indoor smallbore practice is on the calendar on Saturdays and Sundays from 2 to 6 PM, as well as Tuesdays from 6 to 9 PM.

The Youth Rifle season runs every Friday at 6 PM.

We have planned and scheduled NRA Reloading classes for February, March, and April. These will be on the Sunday of the third weekend of the month.

46 people attended the rifle Special Use classes on January 27 th and 28 th . The next rifle Special Use range session is on February 25 th . There is an additional Special Use classroom session on February 9 th , we added a rifle session on the range on February 11 th .

We are working on a video script to cover rifle and pistol special use renewals. This should be linked to membership renewals, so that special use can be renewed annually by watching the video. The video will be about 6 to 7 minutes long.

The Garand competition will not happen in April.

We are looking to expand the steel targets. We bought three more steel rifle targets, 8" round, for member's use. These can be

mounted on the existing 100, 200, and 300 yard target posts with 2x4 crossbars, or use our new steel target supports. These are Aframe supports that are to be placed right in front of the existing target frames. In this way, the bullet fragments will not cut the paper targets for the next bench. The Aframes are stored out of the way to the left of the 100, 200, and 300 yard targets, and are to be put back when not in use. The steel targets are stored on the backside of the half wall behind the firing points. We only accept the use of the club steel targets and supports. Members will have to set up the support crossbars as needed. We have updated and posted the range rules to support this.

The 4x4 target posts on Range 2 may need updating and repair. We are setting up a work party for this. Mark Huber can still be our contact for the steel pipe.

The African Safari presentation by Brian Suddaby Safaris happened last night and we had 18 people attend.

Horacio Delgado suggested a clarification on guest rules for the use of Range 1. The proposed addition is, "Guests under supervision of a member with rifle special use may use all shooting positions and distances."

Martin asked if we could include new member names in the newsletter. We should consider an opt-out provision. Patty will get together with Martin.

Helping Hands Ministries asked for a donation for their auction in March. That is, donating a membership. Joe said he is okay with that.

The BSA Shooting Sports Committee at Fire Mountain Scout Camp needs some information to help them build a sign for Loupe's Last Stand, the Cowboy Action Range we helped them build. The boy scouts are finishing their range. They would like a picture of Gerard Loupe. We will try to find one for them.

Shotgun Report:

Joe Rinaldi presented. The Continental Shoot is this Sunday. Thank you to Scott Ray's wife who volunteered to do the food.

Joe mentioned we need more involvement from the Shotgun Committee.

Manager's Report:

Robert Haverstock presented.

We are looking to make a large ammunition order to cover what we need before and after the election. He would like to purchase about \$200,000 of ammunition. Initially starting at \$120,000. We would only pay for it once we receive it. We need to get our order in the queue, or we may not get the order. Dave Levinson moved that we accept Robert's proposal. Joe Maggiora seconded. Passed.

Robert would like to give Victor Rabara access to editing the calendar. We said yes. The tractor needs repair. We are getting it repaired.

Our forklift is now dead. The repair man said it was not worth fixing. Dave L. investigated our usage. We only use it 25 hours per year. However, based on how much it costs to rent one, we could pay for one in about 1 to 2 years. Buying one would be a worthwhile expense. A used forklift would be about \$20,000 to \$30,000. Gabe Shank moved we approve \$25,000 for a forklift and \$5,000 for a cover to park the forklift under. Patty Woolley seconded.

The Sportco Show is March 6th and 7th.

Treasurer's Report:

Joe M presented.

Joe shared a couple bar charts of new members and revenue for several years. The new members chart clearly illustrate that removing our initiation fee attracted more members.

Our overall income number is incorrect in our report. With the correction, we are about \$60,000 positive year to date. We are netting on average about \$6,000 per month. We are making over 5% return on our cash. This is very good.

Trustees Report:

John Sutton presented. So far, we have saved about \$2,000 on our change in internet providers.

We have paid our property taxes even though there was a record in our finances that did not show it as paid.

Payroll went up 3% in January due to new state laws.

\$115,000 was put in our bank fiscal year to date.

John said they talked about ammo purchase at the last trustees meeting.

They also talked about the lead reclamation. They performed some analysis of the amount of lead we could reclaim based on the number of loads of targets we have gone through. We estimate we could reclaim approximately 148 tons of lead. Lead is about \$1 per pound. They are talking to MT2 about the lead reclamation and the possibilities of installing a skeet field. The clubhouse targets need to be cleaned, rubber replaced, and steel replaced. Will do this sometime in April.

Marketing Report:

Peter Goodwin presented.

The African Safari Outfitter session was very successful.

The hunter group had 20 people in the last session. We made signs for them. We will be putting up signs for the Continental shoot.

We continue to work with conservation organizations (Safari Club International, Rocky Mountain Elk Foundation and Ducks Unlimited). The Ducks Unlimited engagement has resulted in interest in a company event.

Peter has found someone to help with the website (Kathryn Koehner). He will be working with her to see if she can help us.

We will be having a 2024 WCW board planning meeting this weekend (February 10 th). We will be running membership and non-member surveys after the meeting.

Old Business:
