# LEAD RECOVERY IS DONE!

We finished lead recovery in the lead traps in the clubhouse.

Tom Colligan, Raymon Crane, Tom Cole, and Jason Panzer were the work crew in May, and Keith Wilson and Tom Cole finished up in June.

Between the two sessions, we pulled out two dozen 5-gallon buckets of lead in chunks.

We found that an oscillating saw worked a lot better than chisels to break the lead loose.

We also replaced the rubber flaps on the bullet traps on positions 1 through 8, and used Coroplast instead of the rubber on traps 9, 10, and 11. We'll see how this works, it may be easier to maintain.

# JUNE 2025 100/200 YARD RIMFIRE MATCH REPORT

The June WCW 100 / 200 Yard Rimfire Benchrest Match was held Saturday June 28<sup>th</sup> on Range 1, but it felt more like a spring day in April or May. We had a record tying 14 competitors this month which included two first time Competitors: Anthony Du and Cathyraye Hyland.

It was a cloudy and drizzly day with the temperatures in the upper 50's. But after the Match was over the sunny came out and it turned into a nice day. The wind was great as it ranged from 0 – 1.1 mph during the match with gusts in the 1.2 to 2.3 mph range. During the 100 yard segment the wind was mostly from the NE which led to some very good scores. However, during the 200 yard segment the wind direction was SSE, NNE, East, South, ESE, West, NW, NE, and ENE. Although the wind speeds were low, 22LR rounds still get pushed around at 200 yards.

There were 9 Competitors that shot scores between 199 – 194 which was outstanding. Keith Wilson started the Match off hot shooting an outstanding 199 out 200 at 100 yards for the top score. The 10 ring on the CBA target is only 0.69 inches in diameter, which means a very tight grouping is required for a 22LR at 100 yards. Bill Ritchie and Eric Carter stayed right with Keith and shot an outstanding 198, only 1 point back and tied for 2<sup>nd</sup> place.

# **Guest topics:**

Gabi -Dale wanted to get everyone's name off the board. Dave took care of it this evening.

Gabi came to the board asking for a grant for US Target Nationals and World Youth Championship archery. About \$5000 each for World Youth, flight, hotel, admin, and registration (Currently paid \$3000 not including flight. Last year she is

eligible.

Need everything submitted by July 1. She does have a history at this tournament and placed 2<sup>nd</sup> at previous tournament. Will be in Winnipeg, CA.

Board will talk about it in the board meeting. Also asked about a youth group celebration. To be decided. Date will be August 17, 2025. Joe moved to approve \$1500 for Gabi, Jack 2nd

David Robinson did a lot of work on benches for archery. It was Scout Eagle project, he and other friends built 6 benches, relocated others. They have concrete benches, so they are sturdy. They should last for a long time.

Benches built from scratch by David. Treated and Trex materials were used to build them. Paid for them out of his own pocket. \$1500. Asked to help cover some of the cost from the range. Dave also recommended donation plaques to help offset costs.

Dave moved to purchase plaques for benches. Donated by Robinson Family on plaques.

Give them a one-year family membership David is also making signs for the archery range.

#### Michael Parent

Runs the FFL. Part of his ability to be here is from his ability to have parcels shipped here and handled by him, A new lease starting in July 1. Same lease since 2022.

Also provided a 3<sup>rd</sup> party logistics contract for receiving parcels. Agents that handle parcels. Sent inquiry to ATF and ATF is fine with the arrangement. Complication is without a brick and mortar location, most manufacturers will not ship.

Michael is classified as sporting goods retailer and the parcels are classed as sporting goods. WCW is the agent and receives them, the parcels are then placed inside the FFL structure. Standard industry practice.

The contract removes liability from WCW and is on the FFL. Legal responsibilities for loss etc. is the FFL's. HB2118 requirements are being met by the structure for the FFL.

Essentially WCW acts as agent if the FFL cannot be here. That is what the contract states. Contract indicates that no WCW members are employees of the FFL. The board still needs to look at the contract and deal in more detail.

Clarifying question on how does UPS know it arrived. Does the range log it into some record? Recording date and time, and tracking number when received. FFL logs when he collects it and signs it out. Will maintain the records for 6 months.

Big concern is if packages arrive, WCW is responsible for it. FFL still takes responsibility for sporting goods package. FFL insurance covers the loss of the parcel, Loss value is listed as \$10. Dave asked how many parcels per month. Likely 7 or 8 packages per week.

Concern about how much time does it take for WCW staff. Robert receives packages all the time and indicates that it's not a big time commitment.

Robert can have access to FFL office in the event that Michael cannot make it that day to log out the packages.

#### Swap Meet:

Club is liable and should not be selling firearms in the clubhouse. If the public is allowed to come into the clubhouse, do they need to go transfer it to the FFL. Liability is transfer in the clubhouse. Insurance will not underwrite a policy if we are selling in the clubhouse but not member to member.

Michael says what we do at a swap meet is not a gun show and doesn't fit the same qualifications that gun shows fall under. Gun shows are basically setup to be able to have these transactions.

Scott says we don't seem to be worse off than last year. All ammo will be marked up and sold to help show in balance sheets.

On the insurance and liability issue, firearms are not being sold at swap meet. They must all go to the FFL for transfer.

2<sup>nd</sup> agenda point

Club contact list. Needs to be completed so people know how to contact us. Email addresses to be updated.

Scott wants positions to be on our badges.

State of the range – roof and back panels are on the shed. Volunteers came out and got it completed. Stuff can now be under cover. Used scissor lift to fix lights on shotgun range. Some bad transformers. Might have parts to rebuild the cans now. Do we want to switch to LEDs?

LEDs would be cheaper to run but we have extra bulbs. LEDs will cost more to start. Can budget for later years as we have spare stuff for now. Martin and others have cleaned out the traps in the clubhouse. 12 out of 22 are done, remaining 10 still to be completed.

Got carts for the tables now so it makes it easier to handle the tables. New racks for chairs as well and it can handle all our chairs.

Hallway from back to front will need to convert for ADA. Need to investigate how to get there. ADA requires specific space (36 inches). Dave removed door frames to get measurements. Will thinset the frames so we don't need door frames.

Challenge as per Dave, when we do modifications, we need permits. Aaron says permits not required for this work. Doors will require crash bars to get out. Leaving doors off will negate this requirements.

Dave is asking for members to throw trash out at home. He is finding old microwaves and other things in our dumpsters. Trash collection is costing a lot.

Mr. Barton will drive in the parade and asked if we want to be advertised in the July 4<sup>th</sup> parade? Board says yes. It will cost to create now boards.

Robert wants to work on some new uniforms for the range masters.

Badges – complaints from members about missing badges. Committee is one member. Patty is busy with a lot of duties. Badges will now be mailed to existing addresses.

Ultimately will have on-demand badges at the range.

When renew online, choose option to pick up vs mailing.

This is a financial things due to postal rates to mail these out. Decision to mail badges should have been brought to the board first because it is a financial decision, per by-laws. Decision was made to help overcome the printing issue. Also mentioned that if membership is too busy for creating, how can it mailing solve the problem as that will take more time than just printing and have them available for pick up.

Do range masters have time to do the badge printing or do we hire someone to do this. We should be able to print onsite.

Complaints have been piling up and needs to be taken care of. Existing machine can only print on one side and has issues that don't appear to be fixable. We need to replace it.

Do we need an office person? Range masters should be on the ranges.

Only need to do that 3 stands. 5 stand gets full color. Rabbits and full color can be placed in areas where they will be used only where needed. New order will be in the fall.

Robert indicated we should evaluate profits on these before we make a decision on increasing costs or not.

Joe and Scott will continue to negotiate with Michael.
