

AGREEMENT OF ASSOCIATION OF THE WILD LIFE COMMITTEE OF WASHINGTON

KNOW ALL MEN BY THESE PRESENTS that we, the undersigned, citizens of the United States of America and residents of the State of Washington, are desirous of associating ourselves with the intention of forming a social, educational and benevolent organization for the mutual and reciprocal benefits to ourselves as a body politic and corporate, under and by virtue of Sections 3872 and 3883 inclusive, Remington's Code, relating to the creation and organization of social, charitable and educational associations, and therefore we do hereby adopt the following agreement of association:

SECTION I

The name of the corporation shall be the Wild Life Committee of Washington.

SECTION II

The Fundamental Purpose of the club is:

To give the average sports minded citizen the opportunity to participate in a non-political, non-partisan organization, interested only in the preservation, conservation and propagation of wild life in our fields, forests, and streams.

To respect the rights of all land owners and farmers.

To instill in the minds of our youth the proper handling of all fire arms, the obeyance of all laws in the handling of such, and to carry on an educational program which will make for a better sportsman and citizen.

To aid in the elimination of polution of our inland waters.

SECTION III


This corporation shall have no capital stock but its membership shall consist of the subscribers hereto and such members as shall be admitted to this corporation upon such terms and conditions and to such number and with such qualifications as may be prescribed in the by-laws of said corporation hereinafter to be adopted.
