## President's Message

The Holidays are already upon us, and our schedules are being filled with shopping, volunteer work, social events, parties and family gatherings. It is, undeniably, a very busy and stressful time of the year. When you do have time to take a break and decide to wander our way, please take a moment to check the WCW Club Calendar and verify the range you want to use is available. We don't want to be a source of frustration or disappointment, especially this time of year. We have made some changes regarding our Special Use range hours posted on our website. We experienced some confusion from staff and members after moving to our winter operating hours. Unfortunately, that led to a few disappointing outcomes for our members that have since been corrected. Please keep in mind that our operating hours are dictated by available lighting or a lack thereof. As an example, our Rifle ranges cannot safely accommodate shooters after sundown given their lack of sufficient lighting, so we must close both Range 1 & 2 at sunset. Our Pistol range (range 3), however, can be used after public hours until 7:00 PM by Special Use Members given the available lighting. Please make sure you arrive well ahead of our Special Use closing hours to have a chance to shoot. Also, if you don't have a gate key to let yourself out after shooting, pay \$10 and get one. Otherwise, a Rangemaster may ask you to leave the property, so you don't get locked in.

We are receiving more calls from our members for Youth Focused Sports Programs.

Disciplines in demand include Archery, Air gun, Rimfire, Pistol and Shotgun. We have the facilities to support all these activities, but we lack the people and parents to lead, administer, supervise and coach these programs. John and Patty Woolley have been doing good work with our Youth Rifle and Shotgun programs, but they can only do so much, and these classes need to be expanded. So, as we look ahead to 2026, I ask you, the members, for help. Our kids deserve these programs and will appreciate your efforts more than you know.

## MEMBERSHIP CORNER

## DONATIONS AND MATCHING FUNDS

As club members, we can get corporate matching from our employers of donations we make to the club. Some employers will also donate funds based on volunteer hours performed by employees or retirees. As an example, Boeing will cash match up to 100% with a minimum, of \$25.00. Volunteer time is paid at \$100.00 per 10 hours worked. Or if teams of 5 or more are volunteering, it is \$20.00 per hour, per team member. Boeing will match 100% per employee per year to a maximum of \$10,00.00 for active employees, and 50% match up to \$3,00 per year for retirees. Check with your employer to see if they offer corporate matching. This could be a good source for donations, as well as increased exposure and recruiting opportunities.

Relay One Expert Division Target One: Keith Wilson placed first with a score of 246 6X. Mike Becwar was second with a score of 246 5X and David Seibert was third at 243 6X. Target Two: Mike Becwar was first with a score of 247 4X, Jason Guo was second at 243 3X, and David Seibert finished third with a score of 241 6X.

Relay Two Sharpshooter Division: Target One. Bryan Schremp placed first with a score of 239 3X. Steven Goodwin placed second with a score of 236 4X, Song Pak was third at 234 5X. Target Two: Jason Pahlman placed first at 239 2X. Song Pak came in second at 237 2X. Bryan Schremp was third at 237 2X.

## BULLSEYE PISTOL LEAGUE

Our indoor bullseye pistol league starts on Thursday, 4 December, and continues through the end of March 2026. There is room for a few more competitors, so if you want to try something more challenging, come out and see how it works. The first relay starts at 7:00 PM and the second relay at 8:15 PM. Unless you have need (say driving a particularly long distance), we will not be reserving positions for a particular relay. It will be first come, first served. We have 11 positions available per relay. If we need to, we can run a third relay. We will be shooting in the IERPA Postal League again and will try to field 12 teams. The cost for this league will be \$80 per shooter.

This is fired with .22 pistols, one handed, at 50 feet in the clubhouse. If you still think bullseye shooting is slow, try the timed and rapid fire stages, with five shots in ten or twenty seconds offhand – accurately!

The matches are 90 shots, starting with three strings of 10 shots each in slow fire, then ten in timed fire, ten in rapid fire, then two strings of ten each in timed fire, and ending in two strings of ten shots each in rapid fire. Come out and improve your pistol shooting through competition.

## NOVEMBER 2025 BENCHREST CENTERFIRE MATCH REPORT

There were twenty one contestants in this month's 300-yard benchrest match with seven in the Expert Division and fourteen contestants in the Sharpshooter Division.

The first relay consisted of seven Expert Division shooters and two Marksmanship Division shooters. The second relay consisted of twelve Sharpshooter Division shooters.

Welcome to newcomers Tom Reagan, Jeff Dirks, and Harjeet Singh.

To accommodate the larger fields, the target boards have been built to accommodate two targets. The competitors shoot targets one and two with a five-minute break between them followed by shooting targets three and four with the same five-minute break.

The weather conditions were moderate with almost no wind resulting in very good scores.

### Relay 1 Expert Division:

Target 1: Jeff Locke placed first with a score of 103. Richard Nicol was second at 102. Parker Letson and Bill Rice tied for third with scores of 101.

Target 2: Jeff Locke finished first again with a score of 104. Parker Letson placed second at 102. Ernie Snyder and Pat Farrell tied for third with scores of 101.

Target 3: Jeff Locke once again placed first with a score of 105. Pat Farrell was second at 103. Bill Rice placed third at 102.

Target 4: Jeff Locke for the fourth consecutive target shot a plus one hundred score of 106. Pat Farrell was second with a score of 103. Bill Rice finished third with a score of 101.

### Relay 2 Sharpshooter Division:

Target 1: Christian Eckhoff was first with a score of 99. John Lowdon placed second with a score of 98. Newcomer Harjeet Singh and Jason Ingram tied for third with scores of 97.

Target 2: Matt Daly was first with a score of 99. Jason Guo placed second at 98. There was a two way tied for third at 96 between Mark Phelps and Tim Turner.

Target 3: John Lowdon placed first with a score of 100. Matt Daly and Jason Guo tied for second with scores of 99. Mark Phelps and Christian Eckhoff tied for fourth with scores of 94.

Target 4: Jason Guo was first with a score of 98. Matt Daly finished second with a score of 95. Jason Ingram, Mark Phelps, John Lowdon and Tim Turner tied for fourth with scores of 94.

In the Expert Division Jeff Locke was the match winner tying the all time high score of 418 he set in February increasing his score by one point on each of the four targets!!! Pat Farrell finished second with a score of 407. Bill Rice was third with a score of 402. Six of the seven competitors in the Expert Division had scores of 397 or higher.

In the Sharpshooter Division Jason Guo finished first with a score of 391. Matt Daly was second at 387. John Lowdon placed third with a score of 385. Christian Eckhoff was fourth at 379.

□ Finance Committee Meeting (December 2):

- o To discuss 2026 pricing (no dues or range fee increases recommended if possible). No decision in the board meeting was made; employee wage is being worked out and being completed.
- o Last 5 months of FY25-26 were positive \$87K.
- o Deck rebuild final costs are not yet factored in.
